**A BILL**

To amend the Internal Revenue Code of 1986 to permanently extend increased expensing limitations, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “America’s Small Busi-  
5 ness Tax Relief Act of 2015”.

6 **SEC. 2. EXPENSING CERTAIN DEPRECIABLE BUSINESS AS-**  
7 **SETS FOR SMALL BUSINESS.**

8 (a) IN GENERAL.—

1           (1) DOLLAR LIMITATION.—Section 179(b)(1) of  
2 the Internal Revenue Code of 1986 is amended by  
3 striking “shall not exceed—” and all that follows  
4 and inserting “shall not exceed \$500,000.”.

5           (2) REDUCTION IN LIMITATION.—Section  
6 179(b)(2) of such Code is amended by striking “ex-  
7 ceeds—” and all that follows and inserting “exceeds  
8 \$2,000,000.”.

9           (b) COMPUTER SOFTWARE.—Section  
10 179(d)(1)(A)(ii) of such Code is amended by striking “,  
11 to which section 167 applies, and which is placed in service  
12 in a taxable year beginning after 2002 and before 2015”  
13 and inserting “and to which section 167 applies”.

14          (c) ELECTION.—Section 179(c)(2) of such Code is  
15 amended—

16           (1) by striking “may not be revoked” and all  
17 that follows through “and before 2015”, and

18           (2) by striking “IRREVOCABLE” in the heading  
19 thereof.

20          (d) AIR CONDITIONING AND HEATING UNITS.—Sec-  
21 tion 179(d)(1) of such Code is amended by striking “and  
22 shall not include air conditioning or heating units”.

23          (e) QUALIFIED REAL PROPERTY.—Section 179(f) of  
24 such Code is amended—

1 (1) by striking “beginning after 2009 and be-  
2 fore 2015” in paragraph (1), and

3 (2) by striking paragraphs (3) and (4).

4 (f) INFLATION ADJUSTMENT.—Section 179(b) of  
5 such Code is amended by adding at the end the following  
6 new paragraph:

7 “(6) INFLATION ADJUSTMENT.—

8 “(A) IN GENERAL.—In the case of any  
9 taxable year beginning after 2015, the dollar  
10 amounts in paragraphs (1) and (2) shall each  
11 be increased by an amount equal to—

12 “(i) such dollar amount, multiplied by

13 “(ii) the cost-of-living adjustment de-  
14 termined under section 1(f)(3) for the cal-  
15 endar year in which the taxable year be-  
16 gins, determined by substituting ‘calendar  
17 year 2014’ for ‘calendar year 1992’ in sub-  
18 paragraph (B) thereof.

19 “(B) ROUNDING.—The amount of any in-  
20 crease under subparagraph (A) shall be round-  
21 ed to the nearest multiple of \$10,000.”.

22 (g) EFFECTIVE DATE.—The amendments made by  
23 section shall apply to taxable years beginning after De-  
24 cember 31, 2014.

1 **SEC. 3. BUDGETARY EFFECTS.**

2       The budgetary effects of this Act shall not be entered  
3 on either PAYGO scorecard maintained pursuant to sec-  
4 tion 4(d) of the Statutory Pay-As-You-Go Act of 2010.
