AN ACT

To extend the Andean Trade Preference Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Andean Trade Pref-
3 erence Extension Act of 2008”.

4 **SEC. 2. ANDEAN TRADE PREFERENCE ACT.**

5 (a) EXTENSION.—Section 208 of the Andean Trade
6 Preference Act (19 U.S.C. 3206) is amended by striking
7 “February 29, 2008” and inserting “December 31,
8 2008”.

9 (b) TREATMENT OF CERTAIN APPAREL ARTICLES.—
10 Section 204(b)(3) of the Andean Trade Preference Act
11 (19 U.S.C. 3203(b)(3)(B)) is amended—

12 (1) in subparagraph (B)—

13 (A) in clause (iii)—

14 (i) in subclause (II), by striking “5
15 succeeding 1-year periods” and inserting
16 “6 succeeding 1-year periods”; and

17 (ii) in subclause (III)(bb), by inserting
18 “and for the succeeding 1-year period,”
19 after “for the 1-year period beginning Oc-
20 tober 1, 2007,”; and

21 (B) in clause (v)(II), by striking “4 suc-
22 ceeding 1-year periods” and inserting “5 suc-
23 ceeding 1-year periods”; and

24 (2) in subparagraph (E)(ii)(II), by striking
25 “December 31, 2006” and inserting “December 31,
26 2008”.

1 **SEC. 3. CUSTOMS USER FEES.**

2 Section 13031(j)(3) of the Consolidated Omnibus
3 Budget Reconciliation Act of 1985 (19 U.S.C. 58c(j)(3))
4 is amended—

5 (1) in subparagraph (A), by striking “December
6 13, 2014” and inserting “December 27, 2014”; and

7 (2) in subparagraph (B)(i), by striking “De-
8 cember 13, 2014” and inserting “December 27,
9 2014”.

10 **SEC. 4. TIME FOR PAYMENT OF CORPORATE ESTIMATED**
11 **TAXES.**

12 The percentage under subparagraph (C) of section
13 401(1) of the Tax Increase Prevention and Reconciliation
14 Act of 2005 in effect on the date of the enactment of this
15 Act is increased by 0.25 percentage points.
