Dear Attorney General James:

I write today to refer The People’s Forum and the Westchester People’s Action Coalition (hereinafter “WESPAC”)—two New York-based organizations that are tax-exempt under Section 501(c)(3) of the Internal Revenue Code—for investigation and revocation of their charitable status in the State. Please see the attached letters to the Internal Revenue Service (“IRS”) and related exhibits and supplementary materials in support of this referral. As the attached information displays, The People’s Forum and WESPAC have aided and abetted riots and unauthorized encampments across the country. This conduct is designed to sow chaos and discord in our society, has involved illegal activities, and raises questions regarding the organization’s compliance with applicable State law in New York.

This referral comes after an investigation by the U.S. House of Representatives’ Committee on Ways and Means (“the Committee”). Shortly after the horrific attack by Hamas on October 7, 2023, the Committee held its first hearing on this issue exploring the connection between antisemitism in the U.S., tax-exempt colleges and universities, and tax-exempt organizations who finance terrorist organizations.¹ Since then, the Committee held additional hearings examining the groups behind much of the antisemitism on college campuses, identified suspicious organizations with ties to terrorist organizations, and gathered information demonstrating suspicious activity by several American-based nonprofit organizations.² Additionally, at the end of September, I sent letters to the IRS demanding that the agency revoke the tax-exempt status of eight nonprofit organizations, including The People’s Forum and



WESPAC, for fueling chaos here in America and possibly terrorism abroad.³ This letter followed similar referrals to the IRS and the U.S. Department of Justice earlier this summer.⁴ While the Committee's activity at the federal level has largely focused on efforts within the IRS and U.S. Department of the Treasury, State Attorneys General are uniquely positioned to hold many of these tax-exempt organizations accountable as well.

As you know, New York law bestows upon the Attorney General the authority to initiate civil and criminal action against charitable organizations that violate State law.⁵ Part of this duty includes proper enforcement and implementation of New York law that prohibits material support for terrorism, including parts of the code that explicitly state that it is unlawful to make a terroristic threat and solicit or provide support for an act of terrorism, among other things.⁶ The language of the relevant New York law, coupled with the facts provided in the attached supplementary information, raises serious concerns regarding whether The People's Forum and WESPAC are complying with relevant State law.

States have an interest in ensuring supporters of terrorism are held accountable. I strongly urge you, as Attorney General of the State of New York, to utilize your authority to apply relevant State laws, including those prohibiting support for terrorist organizations and requiring tax-exempt organizations to comply with certain requirements, to initiate an investigation of The People's Forum and WESPAC. Dear Commissioner Werfel:

I write today to refer The People’s Forum, an American-based, 501(c)(3) tax-exempt organization, for investigation and ultimately revocation of its tax-exempt status. The People’s Forum has engaged in conduct directly intended to incite riots, cause chaos, and disrupt education on college and university campuses and beyond, all despite its stated tax-exempt purpose and mission designed to support the working class. This conduct is designed to sow chaos and discord in our society, has involved illegal activities, and certainly is not in furtherance of any tax-exempt purpose.

As you know, section 7803 of the Internal Revenue Code (“IRC”) grants the Commissioner of the Internal Revenue Service (“IRS”) the authority to execute and apply internal revenue laws,¹ including section 501 of the IRC’s requirements and prohibitions. Pursuant to section 501(c)(3), tax-exempt organizations must be organized and operated exclusively for a tax-exempt purpose, which includes charitable, educational, literary, and other purposes.² However, if a nonprofit organization conducts substantial activities that do not further its exempt purposes, such activity may result in the loss of the organization’s tax-exemption.³

Tax-exempt organizations must meet other requirements to maintain their tax-exempt status. For example, under section 501(c)(3) of the IRC, organizations seeking to receive an exemption from federal taxes are prohibited from certain activity, including being involved in certain types of political activity.⁴ In addition to the prohibitions of section 501, the IRS has also noted that violations of the law are an “antithesis of the public good” and, as such, may be a bar to tax-exemption.⁵ Not only has the IRS found conducting illegal activities to be inconsistent

with tax-exemption, but it has stated that the “planning and sponsoring of such activities are also incompatible with charity and social welfare.”⁶

For example, while mass demonstrations and other confrontational activities are generally permissible under section 501, the IRS previously found that an organization that sponsored protests where members were pressed to commit acts of civil disobedience “did not qualify for IRC 501(c)(3) or (4) exemption.”⁷ When determining whether these types of demonstrations are consistent with IRC section 501(c)(3), the IRS has historically implemented a three-part test which states that such activities are permissible if: (1) the organization’s tax-exempt purpose is charitable; (2) the activities are not illegal, contrary to established public policy, or in conflict with statutory restrictions; and (3) the activities further the organization’s exempt purpose and are reasonably related to the accomplishment of that purpose.⁸

Additionally, under Section 501(p) of the Internal Revenue Code, organizations which have been designated as terrorist organizations cannot maintain tax-exempt status, and the IRS has revoked the tax-exempt status of terrorist organizations.⁹ Along with the prohibition on tax-exempt status for terrorist organizations themselves, the IRS also previously revoked the tax-exempt status of organizations that could not show that it directed funding exclusively for charitable purposes as required under the IRC.¹⁰

Aside from restrictions on conducting illegal activity and acts supporting or promoting civil disobedience, Internal Revenue Manual (“IRM”) Part 7, Chapter 20, Section 6, asserts that “[c]ases involving grants or activities in foreign countries present a higher risk of terrorism, especially in countries where there is war and civil unrest.”¹¹ Given the language of the IRC, IRM, and previous IRS revenue rulings, I am referring the 501(c)(3) tax-exempt organization called The People’s Forum to the IRS based on the facts and reasons stated in the appendix attached below.

As such, I ask that you use your authority to make this and similar referrals a top priority and make certain the IRS moves as quickly as possible to examine this concerning activity and revoke the tax-exempt status of The People’s Forum. Operating at the agency’s historically slow pace is not acceptable given what is occurring in our streets and on our college campuses. The IRS must act quickly to address these serious issues. The People’s Forum: Relevant Facts

Introduction

The People’s Forum is a 501(c)(3) tax-exempt organization based in New York City that describes itself as a “movement incubator for working class and marginalized communities to build unity across historic lines of division at home and abroad.”¹² The organization is funded by Roy Singham, a tech mogul who owns and operates a complex network of American-based, tax-exempt nonprofits that, according to *The New York Times*, “defends China and pushes its propaganda.”¹³ Mr. Singham works in Shanghai and shares office space with the Maku Group, a Chinese media company which “says its goal is to ‘tell China’s story well,’ a term commonly used for foreign propaganda.”¹⁴ The People’s Forum is just one of the several organizations that are part of Mr. Singham’s network of U.S. nonprofits.¹⁵ On April 24, 2024, the Committee on Ways and Means sent a letter to IRS Commissioner Daniel Werfel regarding Mr. Singham’s ties to the Chinese Communist Party and the activities of his tax-exempt organizations.¹⁶

Incitement, Threats, and Support for Civil Unrest

The People’s Forum has been very active in hosting anti-Israel events, some of which have included illegal conduct leading to arrests,¹⁷ since Hamas’s attacks in Israel on October 7. On October 8, just one day after Hamas’s attacks in Israel, The People’s Forum helped organize¹⁸ a pro-Palestine event in Times Square which featured antisemitic speech and displays of swastikas.¹⁹ These events organized and purportedly funded by The People’s Forum also included intimidating and threatening language, including “[f]—k the Jews!”²⁰

In anticipation of these events, The People’s Forum has also incited violence and unrest. For example, mere hours before rioters broke-in and occupied a building on Columbia University’s campus, The People’s Forum encouraged rioters to “re-create the violent protests of ‘the summer of 2020,’”²¹ where tens of thousands of people swarmed cities across the country,

resulting in the activation of the National Guard in 21 states and the deaths of at least six people.²² This message was relayed to over 100 rioters at The People’s Forum’s Manhattan office, and ultimately led to individuals storming Columbia’s campus, using hammers to smash glass doors, and propping tables and chairs up to barricade themselves inside.²³

Support for Antisemitism

In January 2024, Mr. De Los Santos gave an antisemitic speech calling for the destruction of Israel.²⁴ Mr. De Los Santos said that “[w]hen we finally deal that final blow to destroy Israel, when the state of Israel is finally destroyed and erased from history, that will be the single most important blow we can give to destroying capitalism and imperialism in our lifetime.”²⁵ Mr. De Los Santos refused to apologize and said that “to label the group [The People’s Forum] as ‘antisemitic’ is a ‘propaganda trick by apologists for genocide’ adding that ‘we will not apologize.’”²⁶ In January 2024, Representative Richie Torres wrote a letter in which he described Mr. De Los Santos’s comments as “Nazi rhetoric.”²⁷

Conclusion

The People’s Forum’s incitement of violence and illegal conduct is contrary to the public good, does not further its stated tax-exempt purpose. The IRS should revoke The People’s Forum’s tax-exempt status and ensure that tax-exempt dollars do not continue to flow to this organization and ultimately to those who seek to threaten and intimidate others. Please see the exhibits below for numerous examples of activity that fails to advance any tax-exempt purpose.

Chinese Communist Party-allied group behind Hamas-friendly protests in US

- “This has meant **the People’s Forum** hailing China’s ‘new era led by Xi Jinping,’ the Chinese Communist Party’s authoritarian general secretary, as well as hosting events to support China’s ‘revolutionary struggle’ and push back against America’s ‘political persecution of overseas Chinese people, and economic and trade aggression against China.’ It’s also meant hosting events with Code Pink, a left-wing antiwar group that has sought to justify CCP genocide against Uyghurs in China’s Xinjiang region, and Qiao Collective, which ‘aims to challenge rising U.S. aggression towards the People’s Republic of China’ and promotes CCP narratives on social media, according to the New York Times and New Lines Magazine.”
- “**The People’s Forum** is listed on a flyer posted on social media for last Saturday’s national pro-Palestinian march, and it assisted ANSWER, a left-wing coalition that justified Oct. 7, in fundraising and providing transportation details to the public, a Google form shows. The event saw statues defaced and other acts of vandalism, including red paint smeared on the White House gates as protesters chanted ‘F*** Joe Biden’ and tried to climb the fence, according to social media posts.”
- “In late October, **the People’s Forum** even reposted a video on social media of Leila Khaled, a convicted Popular Front for the Liberation of Palestine terrorist, talking about ‘the unbreakable resistance of the Palestinian people to the Zionist project.’”
- “**People’s Forum** is putting it on with at least seven other anti-Israel organizations, including the Palestinian Youth Movement, which helped plan the recent Washington, D.C., protest and has expressed support for PFLP terrorists. Another Thursday organizer also happens to be Al-Awda, a project of a San Francisco charity called Progress Unity Fund, tax forms show.”

I write today to refer Westchester Peace Action Committee Foundation (“WESPAC”) for investigation and ultimately revocation of its tax-exempt status. WESPAC, in conjunction with its fiscally sponsored projects the National Students for Justice in Palestine (“NSJP”), Within Our Lifetime, the U.S. Palestinian Community Network, and the Palestinian Youth Movement, has engaged in conduct that includes inciting riots and conducting activity antithesis to the public good, despite such conduct being contrary to WESPAC’s stated tax-exempt purpose. This conduct is designed to sow chaos and discord in our society, has involved illegal activities, and certainly is not in furtherance of any tax-exempt purpose.

As you know, section 7803 of the Internal Revenue Code (“IRC”) grants the Commissioner of the Internal Revenue Service (“IRS”) the authority to execute and apply internal revenue laws,¹ including section 501 of the IRC’s requirements and prohibitions. Pursuant to section 501(c)(3), tax-exempt organizations must be organized and operated exclusively for a tax-exempt purpose, which includes charitable, educational, literary, and other purposes.² However, if a nonprofit organization conducts substantial activities that do not further its exempt purposes, such activity may result in the loss of the organization’s tax-exemption.³

Tax-exempt organizations must meet other requirements to maintain their tax-exempt status. For example, under section 501(c)(3) of the IRC, organizations seeking to receive an exemption from federal taxes are prohibited from certain activity, including being involved in certain types of political activity.⁴ In addition to the prohibitions of section 501, the IRS has also noted that violations of the law are an “antithesis of the public good” and, as such, may be a bar to tax-exemption.⁵ Not only has the IRS found conducting illegal activities to be inconsistent

with tax-exemption, but it has stated that the “planning and sponsoring of such activities are also incompatible with charity and social welfare.”⁶

For example, while mass demonstrations and other confrontational activities are generally permissible under section 501, the IRS previously found that an organization that sponsored protests where members were pressed to commit acts of civil disobedience “did not qualify for IRC 501(c)(3) or (4) exemption.”⁷ When determining whether these types of demonstrations are consistent with IRC section 501(c)(3), the IRS has historically implemented a three-part test which states that such activities are permissible if: (1) the organization’s tax-exempt purpose is charitable; (2) the activities are not illegal, contrary to established public policy, or in conflict with statutory restrictions; and (3) the activities further the organization’s exempt purpose and are reasonably related to the accomplishment of that purpose.⁸

Additionally, under Section 501(p) of the Internal Revenue Code, organizations which have been designated as terrorist organizations cannot maintain tax-exempt status, and the IRS has revoked the tax-exempt status of terrorist organizations.⁹ Along with the prohibition on tax-exempt status for terrorist organizations themselves, the IRS also previously revoked the tax-exempt status of organizations that could not show that it directed funding exclusively for charitable purposes as required under the IRC.¹⁰

Aside from restrictions on conducting illegal activity and acts supporting or promoting civil disobedience, Internal Revenue Manual (“IRM”) Part 7, Chapter 20, Section 6, asserts that “[c]ases involving grants or activities in foreign countries present a higher risk of terrorism, especially in countries where there is war and civil unrest.”¹¹ Given the language of the IRC, IRM, and previous IRS revenue rulings, I am referring WESPAC, in conjunction with its fiscally sponsored projects NSJP, Within Our Lifetime, the U.S. Palestinian Community Network, and the Palestinian Youth Movement to the IRS based on the facts and reasons stated in the appendix attached below.

As such, I ask that you use your authority to make this and similar referrals a top priority and make certain the IRS moves as quickly as possible to examine and revoke the tax-exempt status of Westchester Peace Action Committee Foundation and its associated fiscally sponsored projects. Operating at the agency’s historically slow pace is not acceptable given what is occurring in our streets and on our college campuses. The IRS must act quickly to address these serious issues. Westchester Peace Action Committee Foundation (“WESPAC”): Relevant Facts

Introduction

Westchester Peace Action Committee Foundation (“WESPAC”), a New York-based 501(c)(3) nonprofit organization, funds and supports activist initiatives including the antisemitic protests and activity that has taken place on tax-exempt college campuses over the last year.¹² WESPAC has especially strong ties to National Students for Justice in Palestine (“NSJP”),¹³ serving as the national organization’s fiscal sponsor.¹⁴ WESPAC also funds a handful of other organizations responsible for antisemitic activity on college campuses, including the Palestinian Youth Movement USA, Adalah-NY, and the U.S. Palestinian Community Network.¹⁵

Ongoing Litigation Involving WESPAC

In May 2024, several law firms representing American and Israeli victims of Hamas’ October 7, 2023, terrorist attack filed a lawsuit in the U.S. District Court for the Eastern Division of Virginia against several anti-Israel groups including one of WESPAC’s fiscally sponsored projects, NSJP.¹⁶ NSJP is the national body of Students for Justice in Palestine (“SJP”), one of the most prominent networks of pro-Palestinian student groups which operates on over 200 campuses across the U.S. and Canada.¹⁷ The complaint against NSJP alleges that the group has provided material support for Hamas through its pro-Hamas propaganda efforts, which the plaintiff describes as “instrumental to Hamas’s terrorist activities and ability to remain functional amid Israel’s response.”¹⁸ Notably, NSJP and SJP have organized and supported activities across U.S. campuses that have resulted in illegal conduct such as harassment and assault of Jewish students, trespassing, and property vandalism, among others. These activities have resulted in numerous arrests.¹⁹

Within Our Lifetime

Within Our Lifetime, another one of WESPAC’s fiscally sponsored projects,²⁰ started out as a student organization when it was created in 2015 under the name NYC Students for Justice in Palestine before later rebranding as Within Our Lifetime.²¹ Since then, the group has been holding rallies in New York City featuring antisemitic language and support for terrorism against Israelis.²² In June 2024, Within Our Lifetime organized a protest in New York City in which they called on protestors to “de-occupy” the Brooklyn Museum.²³ The illegal conduct at this protest led to the arrest of 34 people including the group’s leader, Nerdeen Kiwani, and included antisemitic messaging, the glorification of Hamas, and explicit and open support for terrorist organizations.²⁴

Nerdeen Kiwani, the leader of Within Our Lifetime, has been arrested several times since Hamas attacked Israel on October 7, and has been designated a “Persona Non Grata” on all of Columbia’s University’s properties.²⁵ As of February 2024, Instagram permanently disabled the accounts of Nerdeen Kiwani and Within Our Lifetime for “violations of community guidelines” including its “Dangerous Organizations & Individuals policy.”²⁶

The U.S. Palestinian Community Network

The U.S. Palestinian Community Network, another fiscally sponsored project of WESPAC,²⁷ was part of the anti-Israel protest that took place in July 2024, when Israeli Prime Minister Benjamin Netanyahu visited Washington, D.C. to address a joint session of Congress.²⁸ According to the U.S. Capitol Police, the illegal activity at protests led to roughly 200 arrests on charges stemming from a sit-in inside the Cannon House Office Building – these protests later

bled out throughout Washington, D.C., where there was violence against law enforcement, property vandalism, and the burning of stolen American flags.²⁹

Palestinian Youth Movement

Another fiscally sponsored project of WESPAC, the Palestinian Youth Movement (“PYM”),³⁰ has been responsible for illegal violations both on and off college campuses. In March 2024, PYM organized a protest at an aerospace and defense facility in Garland, Texas which led to over a dozen arrests after protestors blocked the entrance to the facility.³¹ In May 2024, PYM organized an encampment on the University of Texas at Dallas’s campus after being told by school administrators that the encampment could put them at risk of being arrested for trespassing and other charges.³² The illegal encampment led to at least 17 arrests of students and faculty members.³³

Relevant IRS Guidance

According to IRS Revenue Ruling 75-384, antiwar organizations that urge demonstrators “to commit violations of local ordinances and breaches of public order does not qualify for exemption under section 501(c)(3) or (4) of the [Internal Revenue] Code.”³⁴ Based on the multiple instances in which the WESPAC Foundation’s fiscally sponsored projects have led protests that led to arrests due to violations of local ordinances, it is our belief that the WESPAC Foundation does not qualify for tax-exemption under section 501(c)(3).

Conclusion

NSJP, the Palestinian Youth Movement, Within Our Lifetime, and the U.S. Palestinian Community Network do not further WESPAC’s stated tax-exempt purpose. Despite being banned from social media accounts and being responsible for several riots that resulted in hundreds of arrests for illegal conduct, tax-exempt dollars continue to flow to WESPAC and ultimately its fiscally sponsored projects. The IRS should revoke WESPAC’s tax-exempt status. Please see the exhibits below for numerous examples of activity that fails to advance any tax-exempt purpose.

- “Masoud’s ties to anti-Israel groups including **Within Our Lifetime** (WOL), a pro-Palestinian organization that calls for Israel’s destruction in regular protests. The assault on Greenman occurred at a protest organized by the group.”

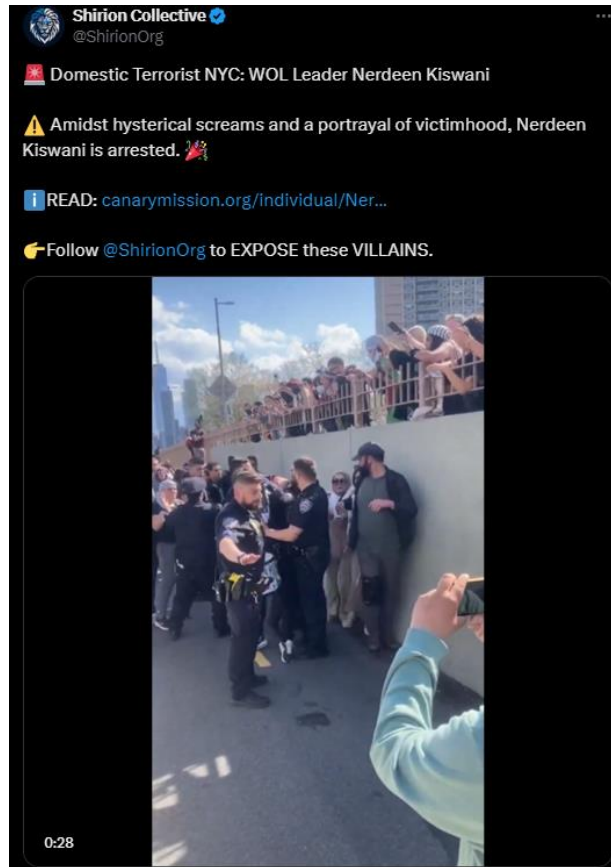

- “The University of Illinois SJP chapter shared a video that showed what appears to be a Hamas terrorist filming himself from inside the home of an Israeli family during the Oct. 7 attack. Dear Attorney General Miyares:

I write today to provide information that may be useful in your ongoing investigation of Americans for Justice in Palestine Educational Foundation (hereinafter “AJP Educational Foundation”)—an organization based in the Commonwealth of Virginia that is tax-exempt under Section 501(c)(3) of the Internal Revenue Code—and American Muslims for Palestine (hereinafter “AMP”). Please see the attached letter to the Internal Revenue Service (“IRS”) and related exhibits and supplementary materials. As the attached information displays, AJP Educational Foundation and AMP have engaged in alarming conduct that includes inciting riots and violence, supporting illegal activity, and conducting activity contrary to the public good. As your office is aware, AMP also holds suspected ties to designated terrorist organizations and may be using American taxpayer dollars to provide funding for groups like Hamas.

This letter comes after an investigation by the U.S. House of Representatives’ Committee on Ways and Means (“the Committee”). Shortly after the horrific attack by Hamas on October 7, 2023, the Committee held its first hearing on this issue exploring the connection between antisemitism in the U.S., tax-exempt colleges and universities, and tax-exempt organizations who finance terrorist organizations.¹ Since then, the Committee held additional hearings examining the groups behind much of the antisemitism on college campuses, identified suspicious organizations with ties to terrorist organizations, and gathered information demonstrating suspicious activity by several American-based nonprofit organizations.² Additionally, at the end of September, I sent a letter to the IRS demanding that the agency revoke the tax-exempt status of eight nonprofit organizations, including AJP Educational

Foundation, for fueling chaos here in America and possibly terrorism abroad.³ This letter followed similar referrals to the IRS and the U.S. Department of Justice earlier this summer.⁴ While the Committee's activity at the federal level has largely focused on efforts within the IRS and U.S. Department of the Treasury, State Attorneys General are uniquely positioned to hold many of these tax-exempt organizations accountable as well.

As you are aware, Virginia law prohibits anyone from providing material support to any individual or organization whose primary objective is to commit and act of terrorism.⁵ Given the activity conducted by AJP Educational Foundation and AMP in the Commonwealth of Virginia, the Committee was happy to see your office take initiative when it launched its investigation and ultimately filed suit against AJP Educational Foundation and AMP last year following the Hamas attacks in Israel.⁶ Other states would benefit from following Virginia's approach.

Thank you for your efforts to thoroughly investigate and hold accountable AJP Educational Foundation and AMP for their fundraising and potential support for terrorist organizations in violation of Virginia law. Dear Commissioner Werfel:

I write today to refer the Americans for Justice in Palestine Educational Foundation (“AJP Educational Foundation”), a tax-exempt 501(c)(3) organization, and American Muslims for Palestine (“AMP”) for investigation and ultimately revocation of their tax-exempt status. AJP Educational Foundation and AMP, in conjunction with its fiscally sponsored project Students for Justice in Palestine (“SJP”) has engaged in conduct that includes inciting riots and violence, supporting illegal activity, and conducting other activity contrary to the public good. AMP also holds suspected ties to designated terrorist organizations despite holding tax-exempt status as a nonprofit organization. This conduct is designed to sow chaos and discord in our society, has involved illegal activities, and certainly is not in furtherance of any tax-exempt purpose.

As you know, section 7803 of the Internal Revenue Code (“IRC”) grants the Commissioner of the Internal Revenue Service (“IRS”) the authority to execute and apply internal revenue laws,¹ including section 501 of the IRC’s requirements and prohibitions. Pursuant to section 501(c)(3), tax-exempt organizations must be organized and operated exclusively for a tax-exempt purpose, which includes charitable, educational, literary, and other purposes.² However, if a nonprofit organization conducts substantial activities that do not further its exempt purposes, such activity may result in the loss of the organization’s tax-exemption.³

Tax-exempt organizations must meet other requirements to maintain their tax-exempt status. For example, under section 501(c)(3) of the IRC, organizations seeking to receive an exemption from federal taxes are prohibited from certain activity, including being involved in certain types of political activity.⁴ In addition to the prohibitions of section 501, the IRS has also noted that violations of the law are an “antithesis of the public good” and, as such, may be a bar

to tax-exemption.⁵ Not only has the IRS found conducting illegal activities to be inconsistent with tax-exemption, but it has stated that the “planning and sponsoring of such activities are also incompatible with charity and social welfare.”⁶

For example, while mass demonstrations and other confrontational activities are generally permissible under section 501, the IRS previously found that an organization that sponsored protests where members were pressed to commit acts of civil disobedience “did not qualify for IRC 501(c)(3) or (4) exemption.”⁷ When determining whether these types of demonstrations are consistent with IRC section 501(c)(3), the IRS has historically implemented a three-part test which states that such activities are permissible if: (1) the organization’s tax-exempt purpose is charitable; (2) the activities are not illegal, contrary to established public policy, or in conflict with statutory restrictions; and (3) the activities further the organization’s exempt purpose and are reasonably related to the accomplishment of that purpose.⁸

Additionally, under Section 501(p) of the Internal Revenue Code, organizations which have been designated as terrorist organizations cannot maintain tax-exempt status, and the IRS has revoked the tax-exempt status of terrorist organizations.⁹ Along with the prohibition on tax-exempt status for terrorist organizations themselves, the IRS also previously revoked the tax-exempt status of organizations that could not show that it directed funding exclusively for charitable purposes as required under the IRC.¹⁰

Aside from restrictions on conducting illegal activity and acts supporting or promoting civil disobedience, Internal Revenue Manual (“IRM”) Part 7, Chapter 20, Section 6, asserts that “[c]ases involving grants or activities in foreign countries present a higher risk of terrorism, especially in countries where there is war and civil unrest.”¹¹ Given the language of the IRC, IRM, and previous IRS revenue rulings, I am referring AJP Educational Foundation and AMP, in conjunction with its fiscally sponsored project SJP, to the IRS based on the facts and reasons stated in the appendix attached below.

As such, I ask that you use your authority to make this and similar referrals a top priority and make certain the IRS moves as quickly as possible to examine and revoke the tax-exempt status of AJP Educational Foundation and AMP. Operating at the agency’s historically slow pace is not acceptable given what is occurring in our streets and on our college campuses. The IRS must act quickly to address these serious issues. **AJP Educational Foundation, Inc. (AJP) & American Muslims for Palestine (AMP):
Relevant Facts**

Introduction

One of the most well-known organizations supporting antisemitism is American Muslims for Palestine (“AMP”). AMP is a Virginia-based nonprofit,¹² which claims to educate, organize, and mobilize the Muslim-American community, as well as allies in other communities, to advance Palestinian rights.¹³ However, this group, in coordination with its 501(c)(3) fiscal sponsor Americans for Justice in Palestine Educational Foundation (“AJP”) and its 501(c)(4) advocacy organization called Americans for Justice in Palestine Action,¹⁴ is an organization with ties to organizations previously associated with terrorist activity and possible financial links to Hamas. Additionally, AMP through AJP provides funding for Students for Justice in Palestine (“SJP”), which has organized and supported extensive antisemitic protests that have resulted in harassment, assault, property vandalization, and trespassing, among other illegal activities.¹⁵

Ties to the Holy Land Foundation and Hamas

For example, three individuals formerly associated with the Holy Land Foundation – an organization now designated by the U.S. Department of the Treasury as a terrorist organization for providing funding to Hamas – have worked for or on behalf of AMP.¹⁶ Additionally, four individuals previously linked to the Islamic Association for Palestine – another organization previously found civilly liable for supporting Hamas – have worked for or on behalf of AMP as well.¹⁷ Further, at least one individual formerly associated with another organization which coordinated with Hamas leaders and contributed to affiliated organizations, KindHearts for Charitable Development, is also linked to AMP.¹⁸

Investigation and Ongoing Litigation Involving AJP, AMP, and SJP

In October 2023, Jason Miyares, the Virginia Attorney General, announced that they are opening an investigation into AMP and their fiscal sponsor AJP.¹⁹ In July 2024, Attorney General Miyares announced that a court ordered AJP to produce records that he requested by a Civil

Investigative Demand (“CID”).²⁰ The CID states that AJP “employed misrepresentations in connection with the solicitation of charitable contributions, permitted the use of funds raised in a charitable solicitation for purposes other than the solicited purpose, and knowingly used or permitted the use of funds raised by a solicitation of contributions to provide support to terrorists, terrorist organizations, terrorist activities, or family members of terrorists.”²¹

In addition, SJP, who collaborates closely with AMP and AJP, is the most well-known and reported network of pro-Palestinian student groups which operates on over 200 campuses across the U.S. and Canada.²² For example, in 2014 alone, AMP spent \$100,000 on campus activities related to SJP.²³

In May 2024, several law firms representing American and Israeli victims of Hamas’ October 7, 2023, terrorist attack filed a lawsuit in the U.S. District Court for the Eastern Division of Virginia against several anti-Israel groups including one of AJP’s fiscally sponsored projects, SJP.²⁴ The complaint against the National Students for Justice in Palestine (“NSJP”), the national group that supports individual SJP chapters, alleges that the group has provided material support for Hamas through its pro-Hamas propaganda efforts which the plaintiff describes as “instrumental to Hamas’s terrorist activities and ability to remain functional amid Israel’s response.”²⁵ The complaint also alleges that NSJP and AMP coordinated the occupation of college campuses across the country to “‘force’ the American government and academia to bend to Hamas’s will.”²⁶ Key to this collaboration and coordination has been a “toolkit” circulated by NSJP to its local SJP chapters on campuses across the country following the Hamas attacks on October 7, 2023.²⁷ This “NSJP Toolkit,” disseminated a day after Hamas’ terrorist attacks on Israel, identified AMP and NSJP as part of a “Unity Intifada” governed by Hamas’ “unified command,” encouraged teach-ins and training on how to organize a protest, and advertised a “National Day of Resistance” following the Hamas attacks.²⁸

Conclusion

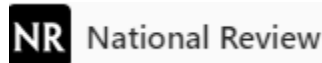

Key Excerpts:

- “Miyares and his office opened an investigation into AMP in October 2023. The attorney general hopes to determine whether AMP has solicited contributions without having registered with the necessary state agencies, as well as the veracity of allegations that AMP has offered support to terrorist organizations.”
- “In the civil investigative demand Miyares issued to AMP in October, the attorney general’s office wrote that, based on its investigation, it has reason to believe the organization may have “knowingly used or permitted the use of funds raised by a solicitation of contributions to provide support to terrorists, terrorist organizations, terrorist activities, or family members of terrorists.”

According to a 2001 FBI memo, the money he raised for the nonprofit was “actually for HAMAS,” and a 1999 Israeli police report detailed Sarsour’s stint in a Ramallah prison on charges related to his involvement with Hamas.”
- “Osama Abuirshaid, the current executive director of American Muslims for Palestine, served as the editor of the Islamic Association for Palestine’s official newspaper — considered by the United States government to be a Hamas propaganda outlet — before joining his new organization. Hamas’s military wing featured Abuirshaid on its website in 2014. The current AMP executive director has ties to the Palestinian Islamic Jihad terrorist organization as well, frequently meeting with a man named Sami al-Arian, who was found to have provided material support to PIJ.

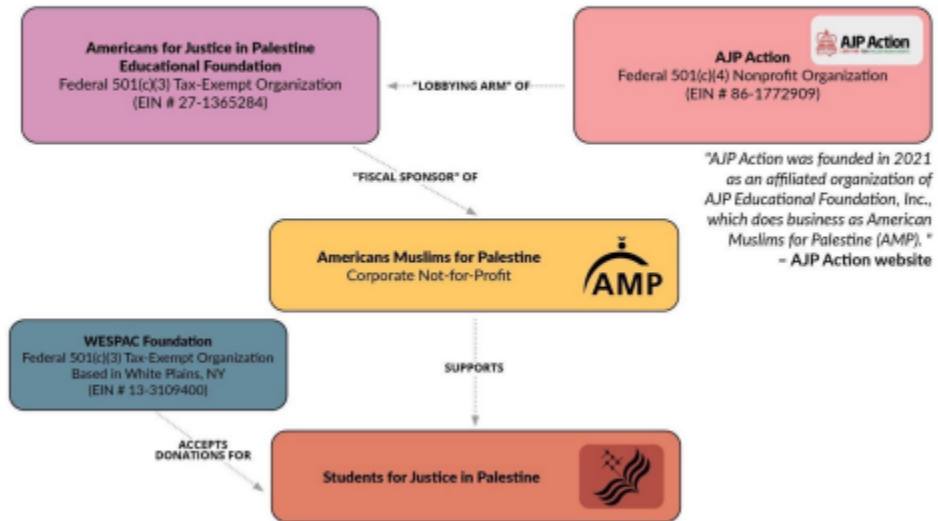

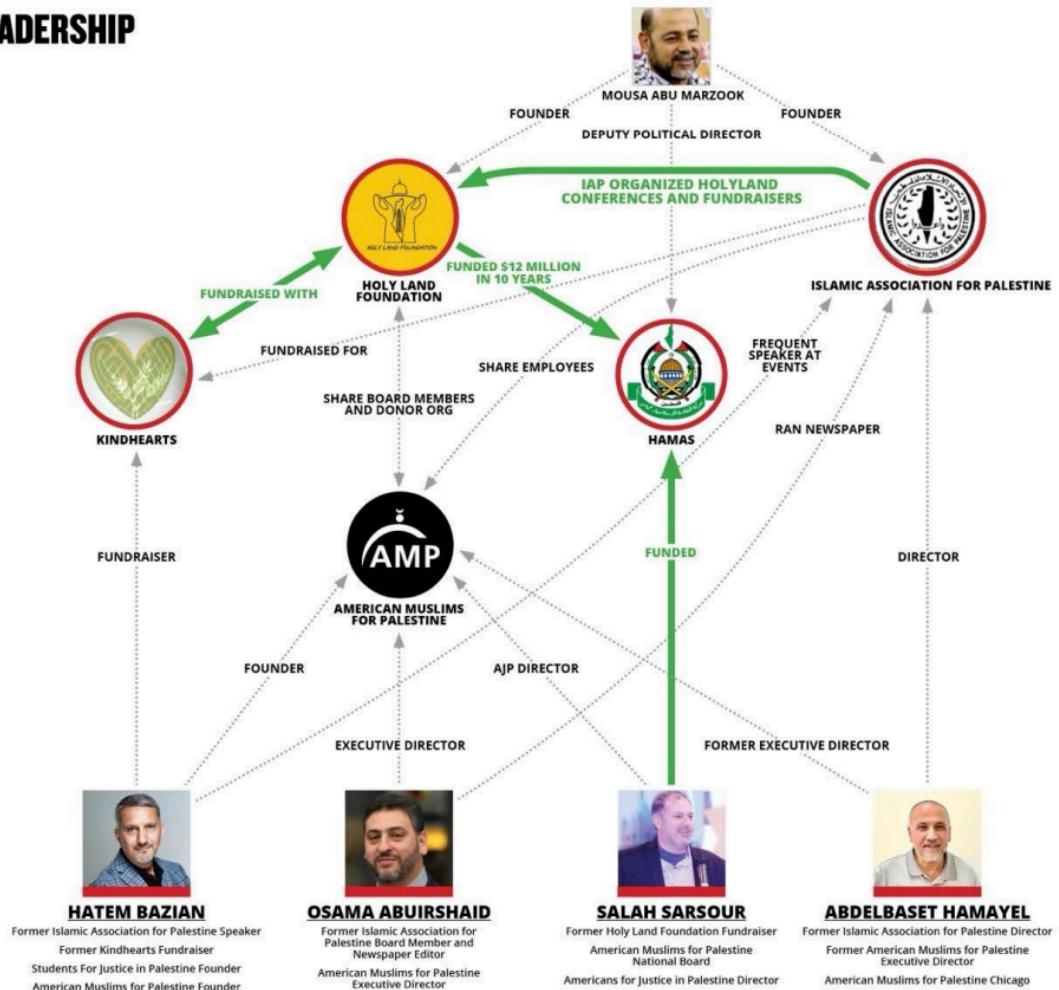

Dear Attorney General Ferguson:

I write today to refer the People Media Project (hereinafter “PMP”)—a Washington-based organization that is tax-exempt under Section 501(c)(3) of the Internal Revenue Code and is also known as *The Palestine Chronicle*—for investigation and revocation of its registration as a charitable organization in the State. Please see the attached letters to the Internal Revenue Service (“IRS”) and U.S. Department of Justice (“DOJ”) as well as related exhibits and supplementary materials in support of this referral. As the attached information displays, PMP has aided and abetted the holding of hostages in Gaza and is suspected of having deep ties to the terrorist organization Hamas as well.¹ This conduct raises serious questions regarding the organization’s compliance with applicable State law in Washington.

This referral comes after an investigation by the U.S. House of Representatives’ Committee on Ways and Means (“the Committee”). Shortly after the horrific attack by Hamas on October 7, 2023, the Committee held its first hearing on this issue exploring the connection between antisemitism in the U.S., tax-exempt colleges and universities, and tax-exempt organizations who finance terrorist organizations.² Since then, the Committee held additional hearings examining the groups behind much of the antisemitism on college campuses, identified suspicious organizations with ties to terrorist organizations, and gathered information demonstrating suspicious activity by several American-based nonprofit organizations.³ Earlier

this summer, I sent a letter to the IRS demanding that the agency revoke the tax-exempt status of PMP, and a letter to the DOJ demanding an investigation of PMP based on the Committee's investigative findings.⁴ While the Committee's activity at the federal level has largely focused on efforts within the IRS and U.S. Department of the Treasury, State Attorneys General are uniquely positioned to hold many of these tax-exempt organizations accountable as well.

As you know, Washington State law allows the Attorney General to open public or private investigations as necessary to determine whether any State registration should be granted, denied, revoked, or suspended.⁵ Part of this duty includes investigating instances where charitable organizations registered in the State are suspected of violating numerous State laws, including those related to inciting violence and riots and promoting unrest in the State.⁶ The facts provided in the attached supplementary information, when considered along with relevant State law, raises serious concerns regarding PMP's compliance.

States have an interest in ensuring supporters of terrorism are held accountable. I strongly urge you, as Attorney General of the State of Washington, to utilize your authority to apply relevant State laws, including those prohibiting support for terrorist organizations and requiring tax-exempt organizations to comply with certain requirements, to initiate an investigation of PMP and ultimately revoke the organization's charitable status in the State. I also ask that you make this and similar referrals a top priority. Thank you in advance for your time, cooperation, and response. Dear Commissioner Werfel:

Terrorism and support for terrorism are not exempt purposes set forth in Section 501(c)(3) of the Internal Revenue Code (“IRC”), and the American people will not tolerate providing generous tax benefits to organizations that support terrorism. I write today to refer the People Media Project—an organization that is known publicly as *The Palestine Chronicle*—for revocation of its tax-exempt status.

It was recently reported that a “journalist” for *The Palestine Chronicle*, located in the Gaza strip, was not really a journalist at all.¹ Rather, he was a terrorist, and he actively held Israeli civilians as hostages in his home.² Despite being an active combatant and a likely member of Hamas—which is a U.S. designated terrorist organization—it appears that he may have been getting paid by the People Media Project using tax free dollars.

The People Media Project has been registered as an American 501(c)(3) organization since at least 2011.³ In a September 28, 2012 determination letter, the Internal Revenue Service (“IRS”) specifically notes that the People Media Project is exempt from Federal income tax due to its classification as a public charity.⁴

Reports from a hostage rescue mission carried out over the weekend by Israeli Defense Forces (“IDF”) show that the People Media Project is not being operated exclusively for its charitable, tax-exempt purpose. The information obtained during the hostage rescue mission is shocking. Abdallah Aljamal—*The Palestine Chronicle* “journalist”—worked as a spokesman for

Hamas-run labor ministry before he was found holding several Israelis hostage in his home in central Gaza.⁵ Although the IDF was able to rescue several hostages who were held by Hamas since the October 7, 2023 attacks, this important development suggests that *The Palestine Chronicle*, which later put out a statement describing Aljamal as “one of its contributors”⁶ in Gaza, is at the very least complicit in supporting Hamas, and at worst a full-fledged financier of terrorism in the Middle East. This revelation, coupled with the fact that *The Palestine Chronicle* has previously published articles calling Hamas “resistance fighters” and falsely accusing Israel of “ethnic cleansing,”⁷ calls into question what People Media Project knew about its operations in the Gaza strip, whether it ever did any due diligence on hiring Aljamal, whether it has other employees actively holding hostages in Gaza, and whether it employs other members of Hamas.

The facts suggest that the People Media Project is not being operated exclusively for its charitable purpose, as required under section 501(c)(3) of the IRC and is instead circumventing its tax-exempt charitable purpose by supporting the terrorist organization, Hamas. In these types of situations, previous IRS decisions⁸ suggest that the People Media Project may be violating the law and conducting its operations contrary to the public good, and in providing material support to Hamas it is also putting its tax-exempt status as a 501(c)(3) organization in serious jeopardy. If there is ever a situation to revoke tax-exempt status for an organization for suspected material support for terrorism, it should certainly be now.

As you know, Section 7803 of the IRC grants the Commissioner of the IRS the authority to execute and apply internal revenue laws,⁹ including Section 501 of the IRC’s requirements and prohibitions. Pursuant to Section 501(c)(3), tax-exempt organizations must be organized and operated exclusively for a tax-exempt purpose, which includes charitable, educational, literary, and other purposes.¹⁰ However, if a nonprofit organization conducts substantial activities that do not further its exempt purposes, such activity may result in the loss of the organization’s tax-exemption.¹¹

Tax-exempt organizations must meet other requirements to maintain tax-exempt status as well. Under Section 501(c)(3) of the IRC, organizations seeking to receive an exemption from federal taxes are prohibited from certain activity, including being involved in certain types of


political activity.¹² In addition to the prohibitions of Section 501, the IRS also notes that violations of the law are an “antithesis of the public good” and, as such, may be a bar to tax-exemption.¹³ Not only has the IRS found the mere conducting of illegal activities to be inconsistent with tax-exemption, but it has also stated that the “planning and sponsoring of such activities are also incompatible with charity and social welfare.”¹⁴

Additionally, terrorist organizations cannot maintain tax-exempt status.¹⁵ For example, the IRS previously revoked the tax-exempt status of organizations suspected of supporting terrorist organizations under the notion that providing material support to terrorist organizations is illegal.¹⁶ In these cases, the IRS revoked the organization’s tax-exempt status after public reporting suggested that the organization provided material support to a terrorist organization and because the nonprofit did not show that it directed its funding exclusively for charitable purposes as required under the IRC.¹⁷

In addition to the prohibition on conducting illegal activity and acts supporting or promoting civil disobedience, the Internal Revenue Manual (“IRM”) Part 7, Chapter 20, Section 6, asserts that “[c]ases involving grants or activities in foreign countries present a higher risk of terrorism, especially in countries where there is war and civil unrest.”¹⁸ Given the language of the IRC and the IRM, and previous IRS revenue rulings, I call on the IRS to revoke the tax-exempt status of the People Media Project, which operates as *The Palestine Chronicle*.

Based on the facts and details stated above, I strongly urge the IRS to utilize its authority to execute and apply internal revenue laws, including those against tax-exempt organizations that fail to comply with the requirements needed to maintain tax-exempt status. Based on what is currently known, it is hard to imagine a result short of revocation of the People Media Project’s tax-exempt status. Dear Attorney General Garland:

We write to urge you to investigate *The Palestine Chronicle* and People Media Project for violating the law, particularly for providing material support to a known terrorist organization in violation of 18 U.S.C. § 2339B, for filing a false tax return in violation of 26 U.S.C. § 7206, and for failing to file a valid tax return and pay estimated taxes in violation of 26 U.S.C. § 7203. While the U.S. House Committee on Ways and Means (“Ways and Means”) already has referred People Media Project to the Internal Revenue Service (“IRS”) for revocation of its tax-exempt status,¹ it appears the group also may have violated several federal laws.

As you may know, it was recently reported that Abdallah Aljamal, a former spokesperson for the Hamas-run labor ministry and a “journalist” for *The Palestine Chronicle*, located in the Gaza strip, actively held Israeli civilians hostage in his home at the behest of Hamas,² a U.S. designated terrorist organization since 1997.³ During his time as a “journalist,” Mr. Aljamal was listed as a “correspondent” on *The Palestine Chronicle*’s website, but the publication later changed the description to “contributor” after news of his holding innocent Israeli hostages was

reported around the world.⁴

The Palestine Chronicle, which advertises itself as a publication that covers “freedom and democracy,”⁵ is also known as People Media Project, an American based 501(c)(3) organization,⁶ which has been organized as a charitable, nonprofit organization since at least 2012.⁷

In addition to its ties to Hamas and terrorism in the Gaza strip, it appears that *The Palestine Chronicle* and People Media Project may have ties to Iran. The publication’s founder and editor-in-chief, Ramzy Baroud, formerly served as an editor and executive for Al Jazeera,⁸ and has also written for *Kayhan International*, an outlet that reportedly is funded by Iran’s supreme leader.⁹ Notably, *Kayhan International* has had six of its published writers appear on state-controlled sites that were previously seized in 2020 by the U.S. government after finding that Iran’s Islamic Revolutionary Guard Corps unlawfully used them to further a global covert influence campaign.¹⁰

According to the U.S. Department of the Treasury, Iran’s Islamic Revolutionary Guard Corps – Qods Force “has enabled Hamas’ . . . terrorist activities, to include the transfer of hundreds of millions of dollars in financial assistance and provision of weapons and operational training.”¹¹ Given the already well-documented connections to Hamas and terrorist activity in the Gaza strip, it is especially concerning that *The Palestine Chronicle*’s editor-in-chief also appears to have close ties to a publication funded by Iran.

Pursuant to 18 U.S.C. § 2339B, “[w]hoever knowingly provides material support or resources to a foreign terrorist organization, or attempts or conspires to do so, shall be fined under this title or imprisoned not more than 20 years, or both, and, if the death of any person results, shall be imprisoned for any term of years or for life”¹² and, based on the facts available, *The Palestine Chronicle* and People Media Project appear to be at the very least complicit in supporting Hamas, and at worst full-fledged financiers of terrorism.

In addition to the suspected material support of terrorism in the Middle East, People Media Project also appears to have filed inconsistent and possibly fraudulent information with state and federal governments regarding the amount of revenue it receives each year. According to the IRS, People Media Project has filed a Form 990-N – a form that organizations may file if their gross receipts are equal to or less than \$50,000 for that taxable year¹³ – every year since being granted tax-exempt status with the exception of tax year 2017, suggesting that its gross receipts have been below the \$50,000 threshold almost every year since 2012.¹⁴ However, based on its filings with the state of Washington, People Media Project reported much more than \$50,000 in revenue for the year in 2020, 2021, and 2022. In fact, People Media Project reported that its revenue was \$91,017; \$59,230; and \$92,036 for fiscal years 2022, 2021, and 2020, respectively.¹⁵

As you know, filing a false tax return is a violation of the law. Pursuant to 26 U.S.C. § 7206, knowingly filing a false federal tax return, which includes making any returns or statements which are asserted to be true, but which are not entirely accurate, is punishable by law, including potential fines or imprisonment for up to three years.¹⁶ Additionally, under 26 U.S.C. § 7203, it is a violation of the law to willfully fail to supply required information on a tax return, which includes information required under Form 990 and Form 990-N.¹⁷ Since People Media Project not only filed inconsistent information with the state and federal government but also failed to file a proper Form 990 for receiving over \$50,000 in gross receipts, DOJ would be remiss to not investigate this matter further.

Based on the facts and details stated above, we strongly urge the DOJ to utilize its authority to investigate *The Palestine Chronicle* and People Media Group for violating federal law, including laws prohibiting material support for terrorism and the filing of false tax returns. We are copying the Internal Revenue Service on this letter, given its role in investigating possible tax-related offenses. 

Dear Attorney General Mayes:

I write today to refer the Alliance for Global Justice (hereinafter, “the Alliance”)—an Arizona-based organization that is tax-exempt under Section 501(c)(3) of the Internal Revenue Code—and its fiscally sponsored project, Samidoun, for investigation. Please see the attached letter to the Internal Revenue Service (“IRS”) and related exhibits and supplementary materials in support of this referral. As the attached information displays, the Alliance has aided and abetted riots and unauthorized encampments across the country, while its fiscally sponsored project Samidoun holds suspicious ties to designated terrorist organizations and foreign adversaries—ties that were recently confirmed when the U.S. Department of the Treasury designated Samidoun as a “sham charity” that serves as a fundraiser for terrorists.¹ Since an Arizona based tax-exempt organization has been funding a group that the U.S. government just designated as a funder of terrorism, you should leverage the power your office holds to launch an investigation into this group.

This referral comes after an investigation by the U.S. House of Representatives’ Committee on Ways and Means (“the Committee”). Shortly after the horrific attack by Hamas on October 7, 2023, the Committee held its first hearing on this issue exploring the connection between antisemitism in the U.S., tax-exempt colleges and universities, and tax-exempt organizations who finance terrorist organizations.² Since then, the Committee held additional hearings examining the groups behind much of the antisemitism on college campuses, identified suspicious organizations with ties to terrorist organizations, and gathered information demonstrating suspicious activity by several American-based nonprofit organizations.³

Additionally, at the end of September, I sent letters to the IRS demanding that the agency revoke the tax-exempt status of eight nonprofit organizations, including the Alliance for Global Justice, for fueling chaos here in America and possibly terrorism abroad.⁴ This letter followed similar referrals to the IRS and the U.S. Department of Justice earlier this summer.⁵ The aforementioned designation of Samidoun as a terrorist funder came after my September letter to the IRS about the Alliance and its fiscally sponsored project, Samidoun. The Alliance has been funding Samidoun with tax-exempt dollars and has a responsibility to maintain records establishing that the funds provided to Samidoun were used for section 501(c)(3) purposes.⁶ This funding stream raises questions regarding the organization's compliance with applicable State law in Arizona. While the Committee's activity at the federal level has largely focused on efforts within the IRS and U.S. Department of the Treasury, State Attorneys General are uniquely positioned to hold many of these tax-exempt organizations accountable as well.

As you know, Arizona State law bestows upon the Attorney General the duty to serve as the chief legal officer of the State.⁷ Part of this duty undoubtedly includes proper enforcement and implementation of Arizona's State code that prohibits material support for terrorism, which explicitly states that it is unlawful to finance an act of terrorism, solicit or incite others to promote acts of terrorism, or induce others to promote an act of terrorism, among other things.⁸ The language of the Arizona State law, coupled with the facts provided in the attached supplementary information, raises serious concerns regarding whether the Alliance is complying with relevant State law.

States have an interest in ensuring supporters of terrorism are held accountable. I strongly urge you, as Attorney General of the State of Arizona, to utilize your authority to apply relevant state laws, including those prohibiting support for terrorist organizations and requiring tax-exempt organizations to comply with certain requirements, to initiate an investigation of the Alliance for Global Justice and its fiscally sponsored project Samidoun. I also ask that you make this and similar referrals a top priority. Thank you in advance for your time, cooperation, and response. 

Dear Commissioner Werfel:

I write today to refer the Alliance for Global Justice, an Arizona-based 501(c)(3) tax-exempt organization, for investigation and ultimately revocation of its tax-exempt status. The Alliance for Global Justice, in conjunction with its fiscally sponsored project, Samidoun, has funded and supported conduct intended to incite violence and instill chaos and holds suspicious ties to designated terrorist organizations. This is despite receiving tax-exempt status as a charitable organization. This conduct is designed to sow chaos and discord in our society, has involved illegal activities, and certainly is not in furtherance of any tax-exempt purpose.

As you know, section 7803 of the Internal Revenue Code (“IRC”) grants the Commissioner of the Internal Revenue Service (“IRS”) the authority to execute and apply internal revenue laws,¹ including section 501 of the IRC’s requirements and prohibitions. Pursuant to section 501(c)(3), tax-exempt organizations must be organized and operated exclusively for a tax-exempt purpose, which includes charitable, educational, literary, and other purposes.² However, if a nonprofit organization conducts substantial activities that do not further its exempt purposes, such activity may result in the loss of the organization’s tax-exemption.³

Tax-exempt organizations must meet other requirements to maintain their tax-exempt status. For example, under section 501(c)(3) of the IRC, organizations seeking to receive an exemption from federal taxes are prohibited from certain activity, including being involved in certain types of political activity.⁴ In addition to the prohibitions of section 501, the IRS has also noted that violations of the law are an “antithesis of the public good” and, as such, may be a bar to tax-exemption.⁵ Not only has the IRS found conducting illegal activities to be inconsistent

with tax-exemption, but it has stated that the “planning and sponsoring of such activities are also incompatible with charity and social welfare.”⁶

For example, while mass demonstrations and other confrontational activities are generally permissible under section 501, the IRS previously found that an organization that sponsored protests where members were pressed to commit acts of civil disobedience “did not qualify for IRC 501(c)(3) or (4) exemption.”⁷ When determining whether these types of demonstrations are consistent with IRC section 501(c)(3), the IRS has historically implemented a three-part test which states that such activities are permissible if: (1) the organization’s tax-exempt purpose is charitable; (2) the activities are not illegal, contrary to established public policy, or in conflict with statutory restrictions; and (3) the activities further the organization’s exempt purpose and are reasonably related to the accomplishment of that purpose.⁸

Additionally, under Section 501(p) of the Internal Revenue Code, organizations which have been designated as terrorist organizations cannot maintain tax-exempt status, and the IRS has revoked the tax-exempt status of terrorist organizations.⁹ Along with the prohibition on tax-exempt status for terrorist organizations themselves, the IRS also previously revoked the tax-exempt status of organizations that could not show that it directed funding exclusively for charitable purposes as required under the IRC.¹⁰

Aside from restrictions on conducting illegal activity and acts supporting or promoting civil disobedience, Internal Revenue Manual (“IRM”) Part 7, Chapter 20, Section 6, asserts that “[c]ases involving grants or activities in foreign countries present a higher risk of terrorism, especially in countries where there is war and civil unrest.”¹¹ Given the language of the IRC, IRM, and previous IRS revenue rulings, I am referring the Alliance for Global Justice and its fiscally sponsored project, Samidoun, to the IRS based on the facts and reasons stated in the appendix attached below.

I ask that you use your authority to make this and similar referrals a top priority and make certain the IRS moves as quickly as possible to examine and revoke the tax-exempt status of the Alliance for Global Justice. Operating at the agency’s historically slow pace is not acceptable given what is occurring in our streets and on our college campuses. The IRS must act quickly to address these serious issues. Alliance for Global Justice: Relevant Facts

Introduction

The Alliance for Global Justice (the “Alliance”) is an Arizona-based 501(c)(3) organization that serves as a fiscal sponsor to over 130 “projects.”¹² The Alliance is an offshoot of the Nicaragua Network, an organization that previously supported the socialist Sandinista regime in Nicaragua.¹³ According to their website, the Alliance envisions “societies which explore and implement alternatives to the unjust domination of governments, global financial institutions and multinational corporations” and their mission is to “achieve social change and economic justice by helping to build a stronger more unified grassroots movement.”¹⁴ According to the Alliance’s 2023 Form 990, its mission is to “achieve social change and economic justice by helping to build a stronger and more unified grassroots movement.”¹⁵

To help bring these visions to life and fulfill its mission, the Alliance fiscally sponsors more than 130 projects.¹⁶ Samidoun is one of the Alliance’s fiscally sponsored projects,¹⁷ and describes itself as “an international network of organizers and activists working to build solidarity with Palestinian prisoners in their struggle for freedom.”¹⁸ However, Samidoun’s conduct and activity suggests more than activism in support of Palestine.

Samidoun’s Ties to a Foreign Terrorist Organization

For example, in February 2021, the National Bureau for Counter Terror Financing of Israel (“NBCTF”) designated Samidoun a terrorist organization and a “part of the Popular Front for the Liberation of Palestine (PFLP)” which “was founded by members of the PFLP in 2012.”¹⁹ The PFLP was designated as a foreign terrorist organization by the U.S. Department of State on October 8, 1997.²⁰ According to the NBCTF, one of Samidoun’s leaders is part of the leadership of the PFLP, has been involved in the establishment of militant cells, and has motivated terrorist activity in “Judea & Samaria and abroad.”²¹

Actions Taken Against Samidoun by Private Companies and Foreign Governments

In January 2023, it was reported that the Alliance and Samidoun were actively fundraising for a France-based organization which partners with the PFLP.²² Later in February 2023, the Alliance announced that it was unable to process credit card donations following reports that the group was fundraising for the PFLP, a U.S. designated foreign terror organization.²³ Additionally in 2023, Germany outlawed Samidoun after determining that the group spread “anti-Israel and antisemitic propaganda under the guise of solidarity for Palestinian prisoners.”²⁴ The ban of Samidoun in Germany came after the group’s leadership was deported from the country in 2019.²⁵ Two of Samidoun’s leaders were also deported from the European Union in 2022.²⁶

In January 2020, Mastercard, Visa, and American Express began blocking direct donations to Samidoun.²⁷ Discover, the credit card company, also cut ties with the Alliance a few months after Israel’s NBCTF designated Samidoun a terrorist organization.²⁸

IRS Guidance on Fiscal Sponsorships

Although fiscal sponsorship is not defined in statute and the IRS has not provided comprehensive guidance regarding fiscal sponsorships, Revenue Ruling 68-489 provides insight into the IRS’s policy regarding fiscal sponsorships.²⁹ Revenue Ruling 68-489 states that 501(c)(3) tax-exempt organizations may accept tax-deductible funds on behalf of an entity that is not tax-exempt under 501(c)(3) if the following three conditions are satisfied: (i) the 501(c)(3) organization ensures that funds are used for exempt purposes “by limiting distributions to specific projects that are in furtherance of its own exempt purposes;” (ii) the 501(c)(3) organization “retains control and discretion as to the use of the funds;” and (iii) the 501(c)(3) organization “maintains records establishing that the funds were used for section 501(c)(3) purposes.”³⁰

Conclusion

Samidoun's designation as a terrorist organization associated with the PFLP³¹ does not further the Alliance's stated tax-exempt purpose. The European Union, Israel, and major credit card companies have recognized Samidoun and the Alliance for what they are, yet tax-exempt dollars continue to flow to the Alliance and ultimately to Samidoun. This must stop. The IRS should revoke the Alliance's tax-exempt status. Please see the exhibits below for numerous examples of activity that fails to advance any tax-exempt purpose.

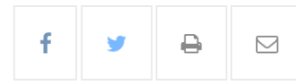

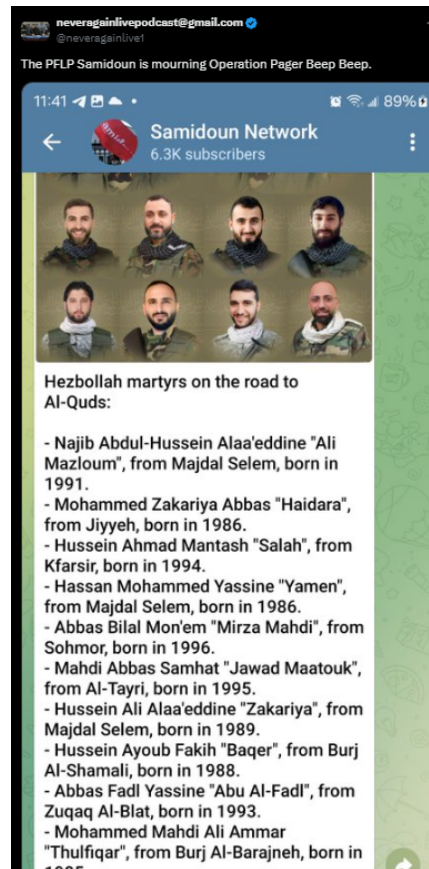

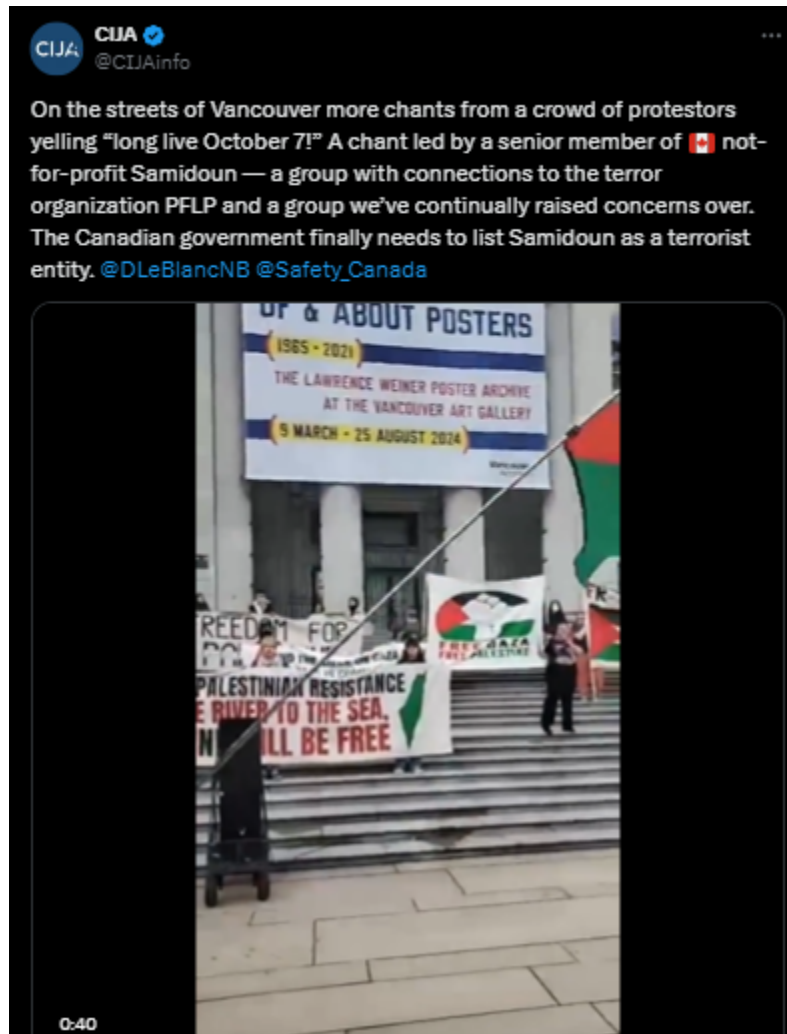

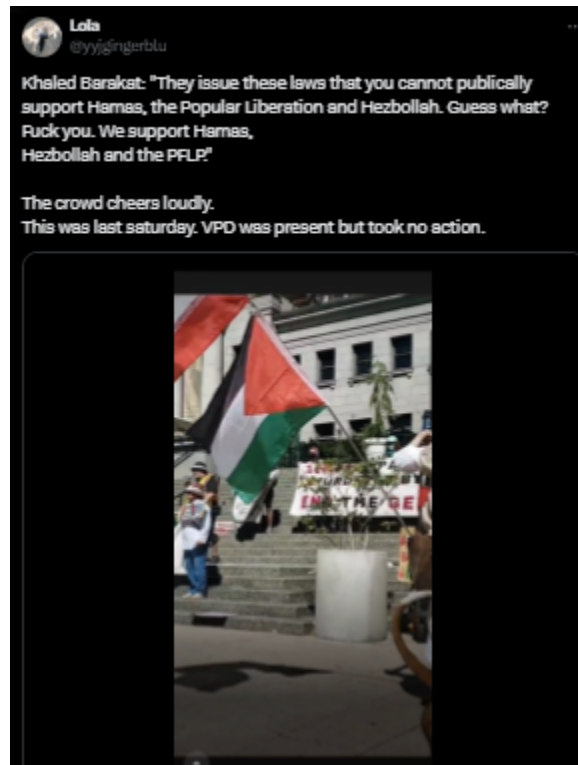

Dear Attorney General Bonta:

I write today to refer Jewish Voice for Peace (hereinafter “JVP”) and the Tides Foundation (hereinafter “Tides”)—two California-based organizations that are tax-exempt under Section 501(c)(3) of the Internal Revenue Code—for revocation of the state-based charitable status for each group. Please see the attached letters to the Internal Revenue Service (“IRS”) and related exhibits and supplementary materials in support of this referral. As the attached information displays, JVP and Tides have aided and abetted riots and unauthorized encampments across the country, including in the State of California. This conduct is designed to sow chaos and discord in our society, has involved illegal activities, and raises questions regarding the organizations’ compliance with applicable State law in California.

This referral comes after an investigation by the U.S. House of Representatives’ Committee on Ways and Means (“the Committee”). Shortly after the horrific attack by Hamas on October 7, 2023, the Committee held its first hearing on this issue exploring the connection between antisemitism in the U.S., tax-exempt colleges and universities, and tax-exempt organizations who finance terrorist organizations.¹ Since then, the Committee held additional hearings examining the groups behind much of the antisemitism on college campuses, identified suspicious organizations with ties to terrorist organizations, and gathered information demonstrating suspicious activity by several American-based nonprofit organizations.² Additionally, at the end of September, I sent letters to the IRS demanding that the agency revoke the tax-exempt status of eight nonprofit organizations, including JVP and Tides, for fueling



chaos here in America and possibly terrorism abroad.³ This letter followed similar referrals to the IRS and the U.S. Department of Justice earlier this summer.⁴ While the Committee's activity at the federal level has largely focused on efforts within the IRS and U.S. Department of the Treasury, State Attorneys General are uniquely positioned to hold many of these tax-exempt organizations accountable as well.

As you know, California State law allows the Attorney General to investigate and bring legal action against charities and fundraisers that misuse charitable assets or engage in fraudulent fundraising practices.⁵ Part of this duty includes proper enforcement and implementation of California's State law when an organization advertises themselves as a charitable organization but may be using American taxpayer dollars to finance illegal conduct and solicit or incite others to promote acts of violence. The language of the California State Code, coupled with the facts provided in the attached supplementary information, raises serious concerns regarding whether the JVP or Tides are complying with relevant State law.

States have an interest in ensuring supporters of terrorism are held accountable. I strongly urge you, as Attorney General of the State of California, to utilize your authority to apply relevant State laws, including those prohibiting support for terrorist organizations and requiring tax-exempt organizations to comply with certain requirements, to initiate an investigation of JVP and Tides. I also ask that you make this and similar referrals a top priority. Thank you in advance for your time, cooperation, and response. Dear Commissioner Werfel:

I write today to refer Jewish Voice for Peace (“JVP”) for investigation and ultimately revocation of its tax-exempt status. JVP has engaged in conduct that includes organizing protests that have turned violent and support for illegal encampments on college campuses, despite its stated tax-exempt purpose as an advocacy and human rights organization. This conduct is designed to sow chaos and discord in our society, has involved illegal activities, and certainly is not in furtherance of any tax-exempt purpose.

As you know, section 7803 of the Internal Revenue Code (“IRC”) grants the Commissioner of the Internal Revenue Service (“IRS”) the authority to execute and apply internal revenue laws,¹ including section 501 of the IRC’s requirements and prohibitions. Pursuant to section 501(c)(3), tax-exempt organizations must be organized and operated exclusively for a tax-exempt purpose, which includes charitable, educational, literary, and other purposes.² However, if a nonprofit organization conducts substantial activities that do not further its exempt purposes, such activity may result in the loss of the organization’s tax-exemption.³

Tax-exempt organizations must meet other requirements to maintain their tax-exempt status. For example, under section 501(c)(3) of the IRC, organizations seeking to receive an exemption from federal taxes are prohibited from certain activity, including being involved in certain types of political activity.⁴ In addition to the prohibitions of section 501, the IRS has also noted that violations of the law are an “antithesis of the public good” and, as such, may be a bar to tax-exemption.⁵ Not only has the IRS found conducting illegal activities to be inconsistent

with tax-exemption, but it has stated that the “planning and sponsoring of such activities are also incompatible with charity and social welfare.”⁶

For example, while mass demonstrations and other confrontational activities are generally permissible under section 501, the IRS previously found that an organization that sponsored protests where members were pressed to commit acts of civil disobedience “did not qualify for IRC 501(c)(3) or (4) exemption.”⁷ When determining whether these types of demonstrations are consistent with IRC section 501(c)(3), the IRS has historically implemented a three-part test which states that such activities are permissible if: (1) the organization’s tax-exempt purpose is charitable; (2) the activities are not illegal, contrary to established public policy, or in conflict with statutory restrictions; and (3) the activities further the organization’s exempt purpose and are reasonably related to the accomplishment of that purpose.⁸

Additionally, under Section 501(p) of the Internal Revenue Code, organizations which have been designated as terrorist organizations cannot maintain tax-exempt status, and the IRS has revoked the tax-exempt status of terrorist organizations.⁹ Along with the prohibition on tax-exempt status for terrorist organizations themselves, the IRS also previously revoked the tax-exempt status of organizations that could not show that it directed funding exclusively for charitable purposes as required under the IRC.¹⁰

Aside from restrictions on conducting illegal activity and acts supporting or promoting civil disobedience, Internal Revenue Manual (“IRM”) Part 7, Chapter 20, Section 6, asserts that “[c]ases involving grants or activities in foreign countries present a higher risk of terrorism, especially in countries where there is war and civil unrest.”¹¹ Given the language of the IRC, IRM, and previous IRS revenue rulings, I am referring JVP to the IRS based on the facts and reasons stated in the appendix attached below.

I ask that you use your authority to make this and similar referrals a top priority and make certain the IRS moves as quickly as possible to examine and revoke the tax-exempt status of Jewish Voice for Peace. Operating at the agency’s historically slow pace is not acceptable given what is occurring in our streets and on our college campuses. The IRS must act quickly to address these serious issues. Jewish Voice for Peace: Relevant Facts

Introduction

Jewish Voice for Peace (“JVP”) is an organization that has been organizing protests and unauthorized encampments on university campuses across the U.S. since Hamas’ attack in Israel on October 7.¹² The radical anti-Zionist organization has a history of sharing antisemitic tropes, expressing support for violence and terrorism, and vilifying Zionism and Zionists.¹³ The number of JVP sponsored events that have included clearly illegal activity is significant as is the number of arrests at JVP events over the last year. This organization is dedicated to violating the law in a misguided effort to make a point – such conduct does not advance a valid tax-exempt purpose.

Support for Illegal Encampments on College Campuses

JVP has participated in, supported, and organized illegal encampments on college campuses across the country,¹⁴ including the one on Columbia University’s campus which led to the arrest over 100 individuals.¹⁵ This is despite the fact that Columbia University previously suspended JVP in November 2023, for violating University policies and for its “threatening rhetoric and intimidation” on campus.¹⁶ Members of JVP also participated in the encampment on the University of Southern California’s campus which led to 93 arrests¹⁷ and the attempted encampment on the University of New Hampshire’s campus which led to 12 arrests.¹⁸

Support for Illegal Activity that has Led to Hundreds of Arrests

In October 2023, 500 people were arrested after protestors staged an illegal sit-in in the U.S. Capitol.¹⁹ Only one month later, in November 2023, JVP organized a protest outside the Israeli consulate in Chicago which led to over 100 arrests after protestors blocked the entrance to

the premises.²⁰ In February 2024, JVP organized a protest in New York City outside the offices of U.S. Senators Chuck Schumer and Kristen Gillibrand that led to the arrest of 20 individuals for numerous charges including resisting arrest, disorderly conduct, and obstruction of governmental administration.²¹ JVP organized a rally in April 2024, outside the Indiana governor’s mansion, which led to the arrest of more than a dozen people.²² JVP was also an organizer of the anti-Israel protest that took place in July 2024, when Israeli Prime Minister Benjamin Netanyahu visited Washington, D.C to address a joint session of Congress.²³ According to the U.S. Capitol Police, the protests led to roughly 200 arrests on charges stemming from a sit-in inside the Cannon House Office Building.²⁴ Protests turned ugly that day and included violence towards law enforcement and the vandalization of public property.²⁵

Relevant IRS Guidance

According to IRS Revenue Ruling 75-384, antiwar organizations that urge demonstrators “to commit violations of local ordinances and breaches of public order does not qualify for exemption under section 501(c)(3) or (4) of the [Internal Revenue] Code.”²⁶ Based on the multiple instances in which JVP has led protests and encampments which have led to arrests due to violations of local ordinances, it is our belief that the JVP does not qualify for tax-exemption under Section 501(c)(3).

Conclusion

JVP’s incitement of violence and riots, and general conduct and activity that is contrary to the public good and does not further its stated tax-exempt purpose. Many of JVP’s events are designed to break the law, as demonstrated by the sheer number of arrests described in this appendix. Organizing illegal activity is not an exempt purpose. As such, the IRS should revoke JVP’s tax-exempt status. Please see the exhibits below for numerous examples of activity that fails to advance any tax-exempt purpose.

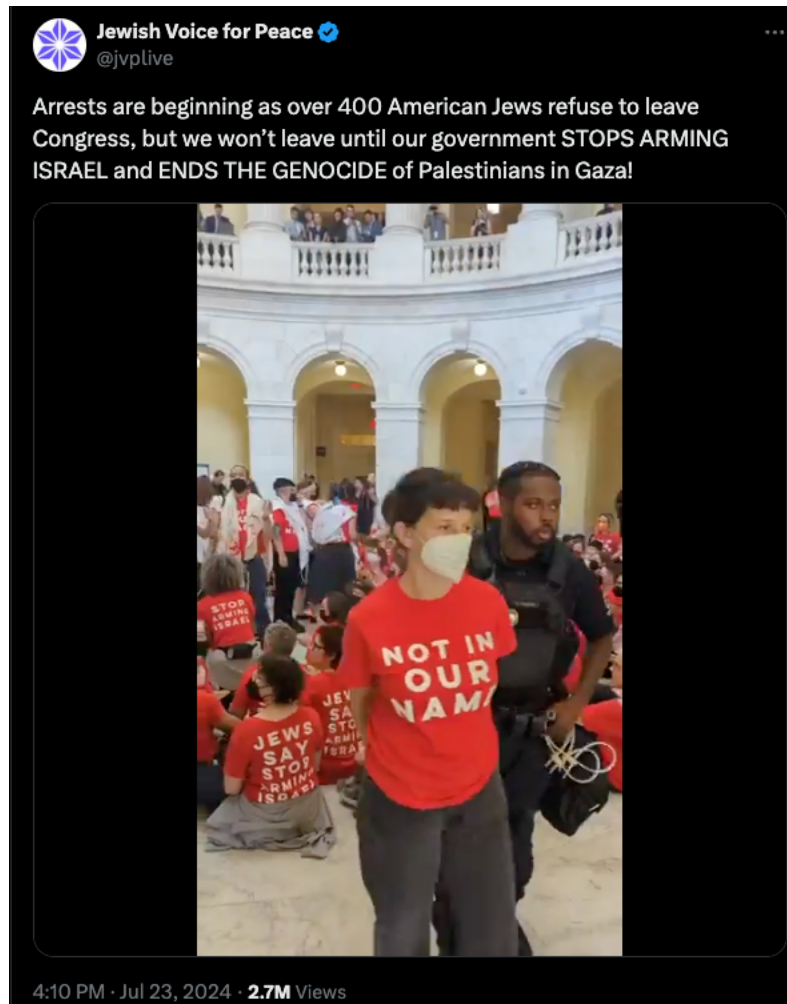

Dear Commissioner Werfel:

I write today to refer the Tides Foundation, an American-based, 501(c)(3) tax-exempt organization, for investigation and ultimately revocation of its tax-exempt status. The Tides Foundation, in conjunction with its partners the Adalah Justice Project and the Arab Resource and Organizing Center, has engaged in conduct directly intended to incite riots, cause chaos, and disrupt college campuses – including acting as one of the largest funders for several groups involved in antisemitic activity across the country – all despite its stated tax-exempt purpose and charitable mission. This conduct is designed to sow chaos and discord in our society, has involved illegal activities, and certainly is not in furtherance of any tax-exempt purpose.

As you know, section 7803 of the Internal Revenue Code (“IRC”) grants the Commissioner of the Internal Revenue Service (“IRS”) the authority to execute and apply internal revenue laws,¹ including section 501 of the IRC’s requirements and prohibitions. Pursuant to section 501(c)(3), tax-exempt organizations must be organized and operated exclusively for a tax-exempt purpose, which includes charitable, educational, literary, and other purposes.² However, if a nonprofit organization conducts substantial activities that do not further its exempt purposes, such activity may result in the loss of the organization’s tax-exemption.³

Tax-exempt organizations must meet other requirements to maintain their tax-exempt status. For example, under section 501(c)(3) of the IRC, organizations seeking to receive an exemption from federal taxes are prohibited from certain activity, including being involved in certain types of political activity.⁴ In addition to the prohibitions of section 501, the IRS has also noted that violations of the law are an “antithesis of the public good” and, as such, may be a bar to tax-exemption.⁵ Not only has the IRS found conducting illegal activities to be inconsistent

with tax-exemption, but it has stated that the “planning and sponsoring of such activities are also incompatible with charity and social welfare.”⁶

For example, while mass demonstrations and other confrontational activities are generally permissible under section 501, the IRS previously found that an organization that sponsored protests where members were pressed to commit acts of civil disobedience “did not qualify for IRC 501(c)(3) or (4) exemption.”⁷ When determining whether these types of demonstrations are consistent with IRC section 501(c)(3), the IRS has historically implemented a three-part test which states that such activities are permissible if: (1) the organization’s tax-exempt purpose is charitable; (2) the activities are not illegal, contrary to established public policy, or in conflict with statutory restrictions; and (3) the activities further the organization’s exempt purpose and are reasonably related to the accomplishment of that purpose.⁸

Additionally, under Section 501(p) of the Internal Revenue Code, organizations which have been designated as terrorist organizations cannot maintain tax-exempt status, and the IRS has revoked the tax-exempt status of terrorist organizations.⁹ Along with the prohibition on tax-exempt status for terrorist organizations themselves, the IRS also previously revoked the tax-exempt status of organizations that could not show that it directed funding exclusively for charitable purposes as required under the IRC.¹⁰

Aside from restrictions on conducting illegal activity and acts supporting or promoting civil disobedience, Internal Revenue Manual (“IRM”) Part 7, Chapter 20, Section 6, asserts that “[c]ases involving grants or activities in foreign countries present a higher risk of terrorism, especially in countries where there is war and civil unrest.”¹¹ Given the language of the IRC, IRM, and previous IRS revenue rulings, I am referring the Tides Foundation, along with its partners the Adalah Justice Project and the Arab Resource and Organizing Center, to the IRS based on the facts and reasons stated in the appendix attached below.

As such, I ask that you use your authority to make this and similar referrals a top priority and make certain the IRS moves as quickly as possible to examine and revoke the tax-exempt status of the Tides Foundation and its partners. Operating at the agency’s historically slow pace is not acceptable given what is occurring in our streets and on our college campuses. The IRS must act quickly to address these serious issues. Tides Foundation: Relevant Facts

Introduction

The Tides Foundation is a 501(c)(3) that is part of the Tides nexus.¹² The Tides nexus is a network of eight related left-leaning grant-making organizations which includes seven 501(c)(3) charities and one 501(c)(4) advocacy group.¹³ In a May 2024 article from *Politico* titled “Pro-Palestinian protesters are backed by a surprising source: Biden’s biggest donors,” the Tides Foundation was highlighted as a tax-exempt organization that has provided funding to several groups involved in the antisemitic activities on college campuses, including Jewish Voice for Peace and IfNotNow.¹⁴ The group also supports Palestine Legal,¹⁵ the Adalah Justice Project,¹⁶ and the Arab Resource and Organizing Center (“AROC”).¹⁷

Support for Terror Organizations and Illegal Activity

In August 2022, Palestine Legal was a signatory on a letter to President Biden condemning Israel’s decision to designate six Palestine-based groups as terrorist organizations.¹⁸ Palestine Legal and the letter’s other signatories referred to these terrorist organizations as “trusted partners in our collective work to secure human rights for all.”¹⁹ Israel’s Minister of Defense said that the six organizations “were designated as terror organizations because they constitute a network of organizations active undercover on the international front on behalf of the ‘Popular Front [for the Liberation of Palestine]’, to support its activity and further its goals.”²⁰ The Popular Front for the Liberation of Palestine was designated as a foreign terrorist organization by the U.S. Department of State on October 8, 1997.²¹

Adalah Justice Project, another one of the Tides Foundation’s fiscally sponsored projects, has been involved in illegal activity on college campuses and on Capitol Hill. For example, in February 2024, *The Washington Post* reported that U.S. Capitol Police arrested 13 people who were illegally protesting inside of the Cannon House Office Building in a demonstration that was

organized by the Adalah Justice Project along with another group.²² In May 2024, *The Center Square* reported that Sandra Tamari, the executive director of Adalah Justice Project, and her husband were arrested at Washington University while supporting an illegal encampment.²³

The Arab Resource and Organizing Center (“AROC”), a fiscally sponsored project of the Tides Foundation,²⁴ has been involved in several anti-Israel events that have led to arrests. For example, in November 2023, AROC and other groups illegally and dangerously blocked westbound lanes of the Bay Bridge in San Francisco, California which led to the arrests of over 50 people.²⁵ In July 2024, AROC helped organize the anti-Israel event that took place in July 2024, when Israeli Prime Minister Benjamin Netanyahu visited Washington, D.C to address a joint session of Congress.²⁶ According to the U.S. Capitol Police, the protests led to roughly 200 arrests on charges stemming from a sit-in inside the Cannon House Office Building.²⁷ Protests turned ugly that day and included violence towards law enforcement and the vandalization of public property.²⁸

According to IRS Revenue Ruling 75-384, antiwar organizations that urge demonstrators “to commit violations of local ordinances and breaches of public order does not qualify for exemption under section 501(c)(3) or (4) of the [Internal Revenue] Code.”²⁹ Based on the multiple instances in which the Tides Foundation’s fiscally sponsored projects have led protests and arrests due to violations of local ordinances, it is our belief that the Tides Foundation does not qualify for tax-exemption under Section 501(c)(3).

Conclusion

The Tides Foundation’s support for illegal activity, including incitement of violence and threatening behavior, coupled with the fact that it openly partners with projects suspected or having ties to terrorism, does not further the Tides Foundation’s stated tax-exempt purpose. The IRS Should revoke the Tides Foundation’s tax-exempt status. Please see the exhibits below for numerous examples of activity that fails to advance any tax-exempt purpose.

Community Justice Exchange, part of the Soros-funded Tides Center, solicits legal defense donations for arrested protesters

Key Excerpts:

- “Scores of ‘Free Palestine’ protesters across the United States took to the streets Monday to block major airports, highways, and bridges. Those who are arrested will receive bail money and legal support from a left-wing dark money behemoth funded by George Soros, an online fundraising page shows.”
- “The exchange is a project of the **Tides Center**, a left-wing dark money network funded by Soros and other liberal billionaires. 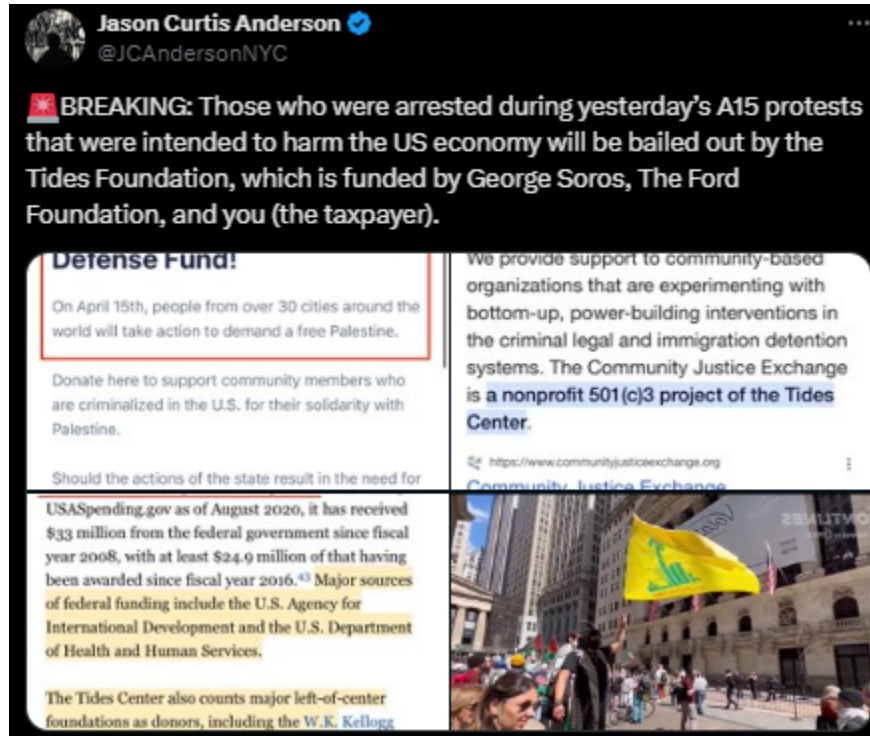

Dear Attorney General Paxton:

I write today to refer United Hands Relief (hereinafter “UHR”)—a Texas-based organization that is tax-exempt under Section 501(c)(3) of the Internal Revenue Code and which is also known as Bait Alkhair—for investigation and revocation of its charitable status in the State. Please see the attached letter to the Internal Revenue Service (“IRS”) and related exhibits and supplementary materials in support of this referral. As the attached information displays, UHR has engaged in conduct that implies numerous possible connections to designated terrorist organizations and raises concerns about the possible use of American taxpayer dollars to support and finance terrorist groups abroad. This conduct raises questions regarding the organization’s compliance with applicable State law in Texas.

This referral comes after an investigation by the U.S. House of Representatives’ Committee on Ways and Means (“the Committee”). Shortly after the horrific attack by Hamas on October 7, 2023, the Committee held its first hearing on this issue exploring the connection between antisemitism in the U.S., tax-exempt colleges and universities, and tax-exempt organizations who finance terrorist organizations.¹ Since then, the Committee held additional hearings examining the groups behind much of the antisemitism on college campuses, identified suspicious organizations with ties to terrorist organizations, and gathered information demonstrating suspicious activity by several American-based nonprofit organizations.² Additionally, at the end of September, I sent a letter to the IRS demanding that the agency revoke the tax-exempt status of eight nonprofit organizations, including UHR, for fueling chaos



here in America and possibly terrorism abroad.³ This letter followed similar referrals to the IRS and the U.S. Department of Justice earlier this summer.⁴ While the Committee's activity at the federal level has largely focused on efforts within the IRS and U.S. Department of the Treasury, State Attorneys General are uniquely positioned to hold many of these tax-exempt organizations accountable as well.

As you know, the State of Texas bestows upon the Attorney General the duty to serve as the top law enforcement officer in the State. Part of this duty undoubtedly includes proper enforcement and implementation of Texas's penal code that prohibits individuals from intentionally raising, soliciting, collecting, or providing material support or resources with intent or knowledge that such support will be used to carry out or aid in committing an offense under Texas State law.⁵ The language of the Texas State Code, coupled with the facts provided in the attached supplementary information, raises serious concerns regarding whether UHR is complying with relevant State law.

States have an interest in ensuring supporters of terrorism are held accountable. I strongly urge you, as Attorney General of the State of Texas, to utilize your authority to apply relevant State laws, including those prohibiting support for terrorist organizations and requiring tax-exempt organizations to comply with certain requirements, to initiate an investigation of UHR. I also ask that you make this and similar referrals a top priority. Thank you in advance for your time, cooperation, and response. Dear Commissioner Werfel:

I write today to refer United Hands Relief Inc. (“United Hands”), a 501(c)(3) tax-exempt organization which is also known as Bait Alkhair, for investigation and ultimately revocation of its tax-exempt status. United Hands has engaged in conduct that suggests numerous connections to designated terrorist organizations and raises concerns about possible financing of terrorist groups abroad, despite its stated tax-exempt purpose of empowering individuals and families within their communities. This conduct is designed to sow chaos and discord in our society, has involved illegal activities, and certainly is not in furtherance of any tax-exempt purpose.

As you know, section 7803 of the Internal Revenue Code (“IRC”) grants the Commissioner of the Internal Revenue Service (“IRS”) the authority to execute and apply internal revenue laws,¹ including section 501 of the IRC’s requirements and prohibitions. Pursuant to section 501(c)(3), tax-exempt organizations must be organized and operated exclusively for a tax-exempt purpose, which includes charitable, educational, literary, and other purposes.² However, if a nonprofit organization conducts substantial activities that do not further its exempt purposes, such activity may result in the loss of the organization’s tax-exemption.³

Tax-exempt organizations must meet other requirements to maintain their tax-exempt status. For example, under section 501(c)(3) of the IRC, organizations seeking to receive an exemption from federal taxes are prohibited from certain activity, including being involved in certain types of political activity.⁴ In addition to the prohibitions of section 501, the IRS has also noted that violations of the law are an “antithesis of the public good” and, as such, may be a bar to tax-exemption.⁵ Not only has the IRS found conducting illegal activities to be inconsistent

with tax-exemption, but it has stated that the “planning and sponsoring of such activities are also incompatible with charity and social welfare.”⁶

For example, while mass demonstrations and other confrontational activities are generally permissible under section 501, the IRS previously found that an organization that sponsored protests where members were pressed to commit acts of civil disobedience “did not qualify for IRC 501(c)(3) or (4) exemption.”⁷ When determining whether these types of demonstrations are consistent with IRC section 501(c)(3), the IRS has historically implemented a three-part test which states that such activities are permissible if: (1) the organization’s tax-exempt purpose is charitable; (2) the activities are not illegal, contrary to established public policy, or in conflict with statutory restrictions; and (3) the activities further the organization’s exempt purpose and are reasonably related to the accomplishment of that purpose.⁸

Additionally, under Section 501(p) of the Internal Revenue Code, organizations which have been designated as terrorist organizations cannot maintain tax-exempt status, and the IRS has revoked the tax-exempt status of terrorist organizations.⁹ Along with the prohibition on tax-exempt status for terrorist organizations themselves, the IRS also previously revoked the tax-exempt status of organizations that could not show that it directed funding exclusively for charitable purposes as required under the IRC.¹⁰

Aside from restrictions on conducting illegal activity and acts supporting or promoting civil disobedience, Internal Revenue Manual (“IRM”) Part 7, Chapter 20, Section 6, asserts that “[c]ases involving grants or activities in foreign countries present a higher risk of terrorism, especially in countries where there is war and civil unrest.”¹¹ Given the language of the IRC, IRM, and previous IRS revenue rulings, I am referring United Hands, also known under the name Bait Alkhair, to the IRS based on the facts and reasons stated in the appendix attached below.

As such, I ask that you use your authority to make this and similar referrals a top priority and make certain the IRS moves as quickly as possible to examine and revoke the tax-exempt status of United Hands Relief Inc. Operating at the agency’s historically slow pace is not acceptable given what is occurring in our streets and on our college campuses. The IRS must act quickly to address these serious issues. United Hands Relief, Inc: Relevant Facts

Introduction

United Hands Relief Inc. (“UHR”), also known as Bait Alkhair,¹² is a 501(c)(3) tax-exempt organization that “[e]ngages in humanitarian projects both locally and internationally to assist those in dire need of assistance.”¹³ The group states that its goal is “to empower individuals and families within their communities.”¹⁴

On July 25, 2024, the House Committee on Ways and Means held a hearing titled *Fueling Chaos: Tracing the Flow of Tax-Exempt Dollars to Antisemitism*.¹⁵ Lara Burns, the head of terrorism research at the George Washington University Program on Extremism, testified that UHR is an “example of a tax-exempt organization that warrants additional scrutiny” due to certain members of their leadership’s ties to terrorism and unusual financial information they reported on their Form 990.¹⁶

Suspected Connections to Terrorist Organizations

In 2022, UHR reported on their Form 990 that Hatem Fariz is the group’s treasurer.¹⁷ In 2003, Mr. Fariz was convicted of providing support to the Palestine Islamic Jihad (“PIJ”) which the U.S. designated as a Foreign Terrorist Organization in 1997.¹⁸ PIJ is a Sunni Islamist militant group that was founded in 1979 as an offshoot of the Muslim Brotherhood that is committed to the destruction of Israel.¹⁹ PIJ’s military wing, the al-Quds Brigades, has conducted several attacks against Israel since the 1990s and occasionally coordinates its operations with Hamas.²⁰ PIJ has been identified as one of the groups that participated in the October 7 attacks against Israel and the group claims responsibility for seizing hostages from Israel that day.²¹

Attachment 1 – Appendix

During the investigation of Mr. Fariz, federal agents allegedly recorded phone calls where he was joking about a terrorist attack in Israel, “explained how to obscure payments made to a terrorism-adjacent charity organization and bragged about beating a young man whom he suspected of collaborating with the Israelis, according to court records.”²² After 14 months of trial, Mr. Fariz pled guilty “to conspiracy to provide material support to a terrorist organization and agreed to a 37-month prison sentence.”²³ In a separate case, Mr. Fariz pled guilty to one count of wire fraud and one count of money laundering connected to food stamp transactions after he stole \$1.4 million from the food stamp program.²⁴

Omar Shahin, the Vice President of UHR,²⁵ once preached “oh (servant) slaves of Allah, there is a Jew behind me; come and kill him.”²⁶ Additionally, Shahin is also a former representative and fundraiser for KindHearts, a group whose assets were frozen by the U.S. Department of the Treasury after the Treasury found KindHearts “coordinated with Hamas leaders and made contributions to Hamas-affiliated organizations.”²⁷ Mr. Shahin denied having any involvement in KindHearts terrorism financing operations saying, “[w]hen they shut down, I had no clue what they were doing... I made sure they are licensed as an American organization with the federal government and states, and that’s all I did, I was just a fundraiser and representative.”²⁸

It is concerning that an individual who has been convicted of providing material support to terrorism, wire fraud, and money laundering is currently the treasurer for an organization that provides aid to Gaza, an area that is currently run by a foreign terrorist organization, Hamas.²⁹

Unusual Financial Activity

In addition to the concerning connections to individuals that have been convicted of providing material support to terrorism, UHR has reported unusual financial activity in their Form 990. According to their most recent filing, the large majority of UHR’s expenditures are allocated towards foreign grants.³⁰ In calendar year 2022, UHR reported granting over \$15

million in foreign expenditures with the large majority going to the Middle East.³¹ UHR reported granting just \$145,000 to domestic organizations during the same year.³² Furthermore, UHR reported over \$18 million in total contributions with over \$11 million coming from noncash contributions of drugs and medical supplies.³³

According to UHR’s most recent publicly available audit report from 2021, their accountant states that UHR “receives substantial in-kind contributions in the form of donated humanitarian relief supplies” and that the supplies “consist of medical supplies and equipment.”³⁴ The audit report also states that contributions are “booked at fair market value in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC).”³⁵

The Committee is concerned that some of the foreign organizations which UHR supports are linked to terrorist organizations including Hamas. A 2019 report from the Meir Amit Intelligence and Terrorism and Information Center, an Israeli-based research group, found that UHR supports a Gaza-based organization known as Generosity Without Limit Association (“Generosity Association”).³⁶ Generosity Association is linked to the Popular Resistance Committees which is the third-largest terrorist organization in Gaza that operates closely with Hamas.³⁷

Conclusion

United Hands Relief Inc.’s potential ties to terrorism and designated terrorist organizations does not further its stated tax-exempt purpose. Enlisting individuals with previous ties to money laundering and terror-financing should raise concerns that the IRS should investigate, yet tax-exempt dollars continue to flow to UHR and possibly terrorist activities. Please see the exhibits below for numerous examples of activity that fails to advance any tax-exempt purpose.

Four Key Moments: Hearing on Tax-Exempt Funding of Antisemitism

July 25, 2024

Key Excerpts:

- “Ms. Lara Burns, terrorism financing expert: ‘I believe that would be effective. If individuals had been affiliated with, and specifically raised funds for organizations that had been designated as terrorist organizations, those individuals should be blocked from being able to participate in additional charitable organizations that receive tax-exempt status. There’s one example of an entity that I mentioned earlier: the **United Hands Relief** that’s based in Texas. One of their directors is a man named Hatem Fariz, who was convicted in Florida for providing support to the Palestinian Islamic jihad. He was also convicted of committing fraud in Illinois. That’s another aspect that I would like to address: individuals that are entrusted with operating tax-exempt organizations. Their records should be fairly clear, free of crimes of moral turpitude, like fraud and waste.’”
