**A BILL**

To amend title XVIII of the Social Security Act to remove cost-sharing responsibilities for chronic care management services under the Medicare program.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REMOVING COST-SHARING RESPONSIBILITIES**  
4 **FOR CHRONIC CARE MANAGEMENT SERV-**  
5 **ICES UNDER PART B OF THE MEDICARE PRO-**  
6 **GRAM.**

7 (a) IN GENERAL.—Section 1833 of the Social Secu-  
8 rity Act (42 U.S.C. 1395l) is amended—

1           (1) in subsection (a)(1), by striking subpara-  
2           graph (Z) and inserting the following: “(Z) with re-  
3           spect to chronic care management services (as de-  
4           scribed in section 1848(b)(8)) furnished on or after  
5           January 1, 2021, the amount paid shall be an  
6           amount equal to 100 percent of the lesser of the ac-  
7           tual charge for such services or the amount deter-  
8           mined under section 1848,”; and

9           (2) in subsection (b)—

10           (A) in paragraph (9), by striking “and” at  
11           the end; and

12           (B) in paragraph (10), by striking the pe-  
13           riod at the end and inserting the following: “,  
14           and (11) such deductible shall not apply with  
15           respect to chronic care management services (as  
16           described in section 1848(b)(8)) furnished on or  
17           after January 1, 2021.”.

18           (b) TECHNICAL AMENDMENTS.—

19           (1) IN GENERAL.—Section 1833(a) of the So-  
20           cial Security Act (42 U.S.C. 1395l(a)) is amended—

21           (A) in paragraph (3)—

22           (i) in subparagraph (A)—

23           (I) by striking “subparagraph  
24           (B)” and inserting “subparagraphs  
25           (B), (C), and (D)”;

1 (II) by striking “or” at the end;

2 and

3 (ii) by adding at the end the following  
4 new subparagraphs:

5 “(C) with respect to Federally qualified  
6 health center services (other than such services  
7 that are described in clause (i) or (ii) of sub-  
8 paragraph (D)) furnished on or after the imple-  
9 mentation date of the prospective payment sys-  
10 tem under section 1834(o) for which payment is  
11 made under such section, the amounts paid  
12 shall be 80 percent of the lesser of the actual  
13 charge or the amount determined under such  
14 section; and

15 “(D) with respect to Federally qualified  
16 health center services and rural health clinic  
17 services that are—

18 “(i) personalized prevention plan serv-  
19 ices (as described in paragraph (1)(X)) or  
20 preventive services (as described in para-  
21 graph (1)(Y)) furnished on or after Janu-  
22 ary 1, 2011; or

23 “(ii) chronic care management serv-  
24 ices (as described in paragraph (1)(Z))  
25 furnished on or after January 1, 2021;

1 the amounts paid shall be equal to 100 percent  
2 of the lesser of the actual charge or the amount  
3 determined under subparagraph (A), section  
4 1834(o), or section 1848, as applicable);” and  
5 (B) by striking the matter following para-  
6 graph (9).

7 (2) CONFORMING AMENDMENTS.—Section  
8 1834(o) of the Social Security Act (42 U.S.C.  
9 1395m(o)) is amended—

10 (A) in paragraph (1)(A), by inserting  
11 “(other than such services described in clause  
12 (i) or (ii) of section 1833(a)(3)(D))” after  
13 “Federally qualified health center services”;  
14 and

15 (B) in paragraph (2)—

16 (i) in subparagraph (A), by inserting  
17 “(other than such services described in  
18 clause (i) or (ii) of section 1833(a)(3)(D))”  
19 after “services”; and

20 (ii) in subparagraph (B)(i)—

21 (I) by inserting “(other than  
22 such services described in clause (i) or  
23 (ii) of section 1833(a)(3)(D))” after  
24 “Federally qualified health center  
25 services”; and

1 (II) by striking “section  
2 1833(a)(1)(Z)” and inserting “sub-  
3 paragraphs (C) and (D) of section  
4 1833(a)(3)”.
