**19.2 million taxpayers who have paid (or are exempt) from the individual mandate penalty;** as compared to only 10.3 million plans paid for on the exchanges.

**25% average increase in premiums** for midlevel plans in 2017 for the millions of Americans trapped in Obamacare healthcare.gov exchanges.
