

**AMENDMENT IN THE NATURE OF A SUBSTITUTE**  
**TO H.R. 1759**  
**OFFERED BY M** . \_\_\_\_\_

Strike all after the enacting clause and insert the following:

**1 SECTION 1. SHORT TITLE.**

2       This Act may be cited as the “Building on Reemploy-  
3 ment Improvements to Deliver Good Employment for  
4 Workers Act” or the “BRIDGE for Workers Act”.

**5 SEC. 2. FINDINGS.**

6       Congress finds the following:

7           (1) The Bipartisan Budget Act of 2018 (Public  
8 Law 115-123) improved program accountability for  
9 effectively serving unemployed workers and made a  
10 significant new investment in reemployment services.

11           (2) Research shows the longer workers are out  
12 of work, the harder it can be to maintain their skills,  
13 professional network, and stable home life.

14           (3) Reemployment services give workers who  
15 might otherwise struggle to find new jobs the tools  
16 that they need to get back to work—such as individ-  
17 ualized career counseling and job search help as well  
18 as local labor market information—and they can

1       serve as an entry point to the workforce development  
2       system.

3           (4) Reemployment services have been dem-  
4       onstrated to reduce the number of weeks that pro-  
5       gram participants receive unemployment benefits by  
6       improving their employment outcomes, including  
7       earnings.

8           (5) Unemployment benefits replace less than  
9       half of working income, on average, so workers who  
10      find new jobs quickly suffer less financial hardship.

11          (6) Combining targeted reemployment services  
12      with unemployment benefits helps keep people at-  
13      tached to the labor force who might otherwise be-  
14      come discouraged and drop out.

15          (7) The Congressional Budget Office estimates  
16      that, over time, investments in reemployment serv-  
17      ices create savings for taxpayers and unemployment  
18      trust funds by reducing spending on unemployment  
19      benefits.

20          (8) Many different types of workers can benefit  
21      from reemployment services. Reemployment services  
22      should be used to shorten the duration of unemploy-  
23      ment for workers even if they are not projected to  
24      fully exhaust their unemployment benefits.

1 **SEC. 3. ELIGIBILITY FOR REEMPLOYMENT SERVICES.**

2 Section 306(a) of the Social Security Act (42 U.S.C.

3 506(a)) is amended—

4 (1) by striking “individuals referred to reem-  
5 ployment services as described in section 303(j)”

6 and inserting “claimants for unemployment com-  
7 pensation, including claimants referred to reemploy-  
8 ment services as described in section 303(j),”; and

9 (2) by striking “such individuals” and inserting  
10 “such claimants”.

Amend the long title to read as follows: “To amend title III of the Social Security Act to extend reemployment services and eligibility assessments to all claimants for unemployment benefits, and for other purposes.”.
