Chairman Smith and Health Subcommittee Chairman Buchanan Announce Subcommittee Hearing on Lowering Costs for Patients: The Health of the Biosimilar Market

House Committee on Ways and Means Chairman Jason Smith (MO-08) and Health Subcommittee Chairman Vern Buchanan (FL-16) announced today that the Subcommittee on Health will hold a hearing to examine the challenges and opportunities surrounding biosimilar uptake and utilization in America's health care system. The hearing will take place on **Tuesday**, **April 8**, **2025**, at **10:00 AM** in **1100 Longworth House Office Building**.

In view of the limited time available to hear the witnesses, oral testimony at this hearing will be from invited witnesses only.
