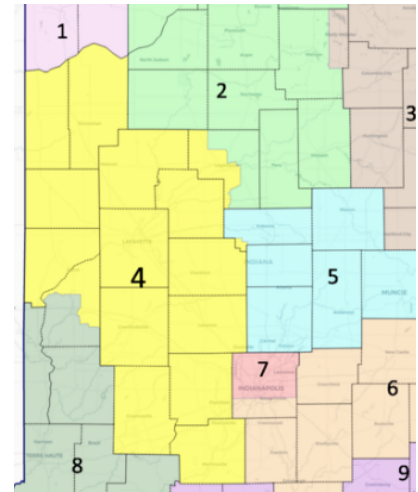




## Key Individual Tax Policies from the Trump Tax Cuts Set to Expire for IN-04 Constituents

### Tax Hikes Looming for IN-04 Residents on December 31, 2025:

- IN-04 is home to **490,740** taxpayers.
- The average taxpayer in IN-04 would see a **23% tax hike** if the Trump Tax Cuts expire.
- A **family of 4** making \$75,704, the median income in IN-04, would see a **\$1,548** tax increase if the Trump Tax Cuts expire.
  - This is worth about **8 weeks of groceries** to a typical family of 4 in the region.



### Impact on IN-04 Residents by the Numbers

|               |  |
|---------------|--|
| <b>92,390</b> | IN-04 families would see their household's Child Tax Credit cut in half.                                   |
| <b>94%</b>    | of IN-04 taxpayers would see their Guaranteed Deduction slashed in half.                                   |
| <b>49,770</b> | Small Businesses in IN-04 would be hit with a 43.4% tax rate if the 199A Small Business Deduction expires. |
| <b>6,706</b>  | IN-04 taxpayers would be impacted by the return of the Alternative Minimum Tax.                            |
| <b>6,883</b>  | Family-Owned Farms in IN-04 would have their Death Tax Exemption slashed in half next year.                |
