Con. Res. 14, which would provide that the provisions of this Act are not effective unless a new \$4,000 tax credit for domestic travel is established that would incentivize travel within the U.S. and ensure America maintains its tourism dominance was not agreed to by a roll call vote of 18 yeas to 25 nays (with a quorum being present).
