AMENDMENT IN THE NATURE OF A SUBSTITUTE TO H.R. 842

OFFERED BY MR. SMITH OF MISSOURI

Strike all after the enacting clause and insert the following:

SECTION 1. SHORT TITLE. This Act may be cited as the "Nancy Gardner Sewell 2 3 Medicare Multi-Cancer Early Detection Screening Cov-4 erage Act". SEC. 2. MEDICARE COVERAGE OF MULTI-CANCER EARLY 6 DETECTION SCREENING TESTS. 7 (a) Coverage.—Section 1861 of the Social Security Act (42 U.S.C. 1395x) is amended— 8 9 (1) in subsection (s)(2)— 10 (A) by striking the semicolon at the end of 11 subparagraph (JJ) and inserting "; and"; and 12 (B) by adding at the end the following new 13 subparagraph: 14 "(KK) multi-cancer early detection screen-15 ing tests (as defined in subsection (nnn));"; and 16 (2) by adding at the end the following new sub-

section:

1	"(nnn) Multi-Cancer Early Detection Screen-
2	ING TESTS.—
3	"(1) IN GENERAL.—The term 'multi-cancer
4	early detection screening test' means a test fur-
5	nished to an individual for the concurrent detection
6	of multiple cancer types across multiple organ sites
7	on or after January 1, 2029, that—
8	"(A) is cleared under section 510(k), clas-
9	sified under section $513(f)(2)$, or approved
10	under section 515 of the Federal Food, Drug,
11	and Cosmetic Act;
12	"(B) is—
13	"(i) a genomic sequencing blood or
14	blood product test that includes the anal-
15	ysis of cell-free nucleic acids; or
16	"(ii) a test based on samples of bio-
17	logical material that provide results com-
18	parable to those obtained with a test de-
19	scribed in clause (i), as determined by the
20	Secretary; and
21	"(C) the Secretary determines is—
22	"(i) reasonable and necessary for the
23	prevention or early detection of an illness
24	or disability; and

1	"(ii) appropriate for individuals enti-
2	tled to benefits under part A or enrolled
3	under part B.
4	"(2) NCD Process.—In making determina-
5	tions under paragraph (1)(C) regarding the coverage
6	of a new test, the Secretary shall use the process for
7	making national coverage determinations (as defined
8	in section 1869(f)(1)(B)) under this title.".
9	(b) Payment and Standards for Multi-Cancer
10	EARLY DETECTION SCREENING TESTS.—
11	(1) In General.—Section 1834 of the Social
12	Security Act (42 U.S.C. 1395m) is amended by add-
13	ing at the end the following new subsection:
14	"(aa) Payment and Standards for Multi-Can-
15	CER EARLY DETECTION SCREENING TESTS.—
16	"(1) Payment amount.—The payment
17	amount for a multi-cancer early detection screening
18	test (as defined in section 1861(nnn)) is—
19	"(A) with respect to such a test furnished
20	before January 1, 2031, equal to the payment
21	amount in effect on the date of the enactment
22	of this subsection for a multi-target stool
23	screening DNA test covered pursuant to section
24	1861(pp)(1)(D); and

1	"(B) with respect to such a test furnished
2	on or after January 1, 2031, equal to the lesser
3	of—
4	"(i) the amount described in subpara-
5	graph (A); or
6	"(ii) the payment amount determined
7	for such test under section 1834A.
8	"(2) Limitations.—
9	"(A) In general.—No payment may be
10	made under this part for a multi-cancer early
11	detection screening test furnished during a year
12	to an individual if—
13	"(i) such individual—
14	"(I) is under 50 years of age; or
15	"(II) as of January 1 of such
16	year, has attained the age specified in
17	subparagraph (B) for such year; or
18	"(ii) such a test was furnished to the
19	individual during the previous 11 months.
20	"(B) Age specified.—For purposes of
21	subparagraph (A)(i)(II), the age specified in
22	this subparagraph is—
23	"(i) for 2029, 65 years of age; and

1	"(ii) for a succeeding year, the age
2	specified in this subparagraph for the pre-
3	ceding year, increased by 1 year.
4	"(C) STANDARDS FOLLOWING USPSTF
5	RATING OF A OR B.—In the case of a multi-can-
6	cer early detection screening test that is rec-
7	ommended with a grade of A or B by the
8	United States Preventive Services Task Force,
9	beginning on the date on which coverage for
10	such test is provided pursuant to section
11	1861(ddd)(1), the preceding provisions of this
12	paragraph shall not apply.".
13	(2) Conforming amendments.—
14	(A) Section 1833 of the Social Security
15	Act (42 U.S.C. 1395l) is amended—
16	(i) in subsection (a)—
17	(I) in paragraph $(1)(D)(i)(I)$, by
18	striking "section 1834(d)(1)" and in-
19	serting "subsection $(d)(1)$ or (aa) of
20	section 1834"; and
21	(II) in paragraph (2)(D)(i)(I), by
22	striking "section 1834(d)(1)" and in-
23	serting "subsection $(d)(1)$ or (aa) of
24	section 1834"; and

1	(ii) in subsection $(h)(1)(A)$, by strik-
2	ing "section 1834(d)(1)" and inserting
3	"subsections $(d)(1)$ and (aa) of section
4	1834".
5	(B) Section 1862(a)(1)(A) of the Social
6	Security Act (42 U.S.C. 1395y(a)(1)(A)) is
7	amended—
8	(i) by striking "or additional preven-
9	tive services" and inserting ", additional
10	preventive services"; and
11	(ii) by inserting ", or multi-cancer
12	early detection screening tests (as defined
13	in section 1861(nnn))" after "(as de-
14	scribed in section 1861(ddd)(1))".
15	(c) Rule of Construction Relating to Other
16	CANCER SCREENING TESTS.—Nothing in this section, in-
17	cluding the amendments made by this section, shall be
18	construed—
19	(1) in the case of an individual who undergoes
20	a multi-cancer early detection screening test, to af-
21	fect coverage under part B of title XVIII of the So-
22	cial Security Act for other cancer screening tests
23	covered under such title, such as screening tests for
24	breast, cervical, colorectal, lung, or prostate cancer;

1 (2) in the case of an individual who undergoes 2 another cancer screening test, to affect coverage 3 under such part for a multi-cancer early detection 4 screening test or the use of such a test as a diag-5 nostic or confirmatory test for a result of the other 6 cancer screening test.
