## Chairman Smith and Health Subcommittee Chairman Buchanan Announce Subcommittee Hearing on Modernizing Care Coordination to Prevent and Treat Chronic Disease

House Committee on Ways and Means Chairman Jason Smith (MO-08) and Health Subcommittee Chairman Vern Buchanan (FL-16) announced today that the Subcommittee on Health will hold a hearing to protect vulnerable patients and prevent chronic disease by improving care coordination and delivery between health care professionals. The hearing will take place on Wednesday, November 19, 2025, at 2:00 PM in 1100 Longworth House Office Building.

In view of the limited time available to hear the witnesses, oral testimony at this hearing will be from invited witnesses only. However, any individual or organization not scheduled for an oral appearance may submit a written statement for consideration by the Committee and for inclusion in the printed record of the hearing.

Please indicate the title of the hearing as the subject line in your submission. Witnesses and submitters are advised that the Committee relies on electronic submissions for printing the official hearing record. The name, company, address, telephone, and fax numbers of each witness must be included in the body of the email. Please exclude any personal identifiable information in the attached submission.
