## AMENDMENT IN THE NATURE OF A SUBSTITUTE TO H.R. 2716

## OFFERED BY MR. SMITH OF MISSOURI

Strike all after the enacting clause and insert the following:

1	SECTION 1. SHORT TITLE.
2	This Act may be cited as the "Ending Improper Pay-
3	ments to Deceased People Act".
4	SEC. 2. IMPROVING COORDINATION BETWEEN FEDERAL
5	AND STATE AGENCIES AND THE DO NOT PAY
6	WORKING SYSTEM.
7	(a) In General.—Section 205(r) of the Social Secu-
8	rity Act (42 U.S.C. 405(r)), as amended by section
9	801(a)(7) of title VIII of division FF of the Consolidated
10	Appropriations Act, 2021 (Public Law 116-260), is
11	amended by striking paragraph (11) and inserting the fol-
12	lowing:
13	"(11) The Commissioner of Social Security
14	shall, to the extent feasible, provide information fur-
15	nished to the Commissioner under paragraph (1) to
16	the agency operating the Do Not Pay working sys-
17	tem described in section 3354(c) of title 31, United
18	States Code, for the authorized uses of the Do Not

1 Pay working system to help prevent improper pay-2 ments of, and support the recovery of improperly 3 paid, benefits or other payments through a coopera-4 tive arrangement with such agency, provided that 5 the requirements of subparagraphs (A) and (B) of 6 paragraph (3) are met with respect to such arrange-7 ment with such agency. The Commissioner of Social 8 Security and the agency operating the Do Not Pay 9 working system shall, while the data described in the 10 preceding sentence is being provided to the agency 11 operating the Do Not Pay working system, enter 12 into an agreement based upon an agreed upon meth-13 odology, which covers the proportional share of State 14 death data costs, which the Commissioner of Social 15 Security and the agency operating the Do Not Pay 16 working system may periodically review. 17 "(12) The Commissioner of Social Security may 18 not record a death to a record that may be provided 19 under this section for any individual unless the Com-20 missioner of Social Security has found it has clear 21 and convincing evidence to support that the indi-22 vidual should be presumed to be deceased.". 23 (b) Improving Coordination Regarding Individ-UALS INCORRECTLY IDENTIFIED AS DECEASED.—Section of the Social Security Act 25 205(r)(7)(42)U.S.C.

3	(Public Law 116-260), is amended by striking "and" at
4	the end of subparagraph (A), by striking the period at
5	the end of subparagraph (B) and inserting "; and", and
6	by adding at the end the following new subparagraph:
7	"(C) notify any agency that has a coopera-
8	tive arrangement with the Commissioner of So-
9	cial Security under paragraph (3) or (11) of the
10	error.''.
11	(c) Effective Date.—The amendments made by
12	this section shall take effect on December 27, 2026.
